The Oneida General Tribal Council met Monday, July 1, 2013 in a duly called meeting with 1,952 registered Tribal members in attendance at 6:15 p.m. The meeting was at the Radisson Hotel and Conference Center. Listed below are the actions taken at the meeting:

1. Chairman Ed Delgado called meeting to order at 6:15 p.m. with 1,932 members in attendance

2. Adoption of the agenda

Motion by Linda Dallas to adopt the agenda, seconded by Paul Smith. Motion approved by a show of hands.

Motion by John Orie that speakers be limited to 2 minutes, presentations to 5 minutes, and power points to 10 minutes, that the Secretary shall be designated timekeeper, and that discussion must be closed first before motions are introduced, seconded by Sherrole Benton. Motion approved by a hand count: 860 yes, 540 no, 43 abstained.

 Adopt resolution Corrective Amendments to the Oneida Code of Laws and Oneida Tribal Policies Regarding References to the Oneida Appeals Commission and/or Oneida Tribal Judicial System

Motion by Melinda J. Danforth to accept the update as information and adopt the resolution on page 87 and 88 that authorizes the BC to make corrective amendments to the Oneida Code of Laws and Tribal Policies, seconded by Jackie Zalim. Motion approved by a two-thirds vote by a show of hands.

c. 2012 Referendum Question 1: Should there be term limits for all board, committee and committee positions, including the Business Committee?

Petitioner Linda Dallas: Direct that all elected and appointed positions for all Boards, Committees and Commissions, excluding the Oneida Business Committee, shall be for a four (4) year term, with a term limit of two terms (totaling eight years), a two (2) year waiting period before running for the same Board, Committee or Commission, and shall be effective for the elections of 2013 and all future elections.

Motion by Linda Dallas to direct that all elected and appointed positions for all Boards, Committees and Commission, excluding the Oneida Business Committee, the Oneida Arts Board and the Oneida Nation Commission on Aging, shall be for a four (4) year term, with a term limit of two terms (totaling eight years), a two (2) year waiting period before running for the same board, committee or commission, and shall be effective for the elections of 2014 and all future elections, seconded by Kathy Mauritz. Motion failed by a show of hands
