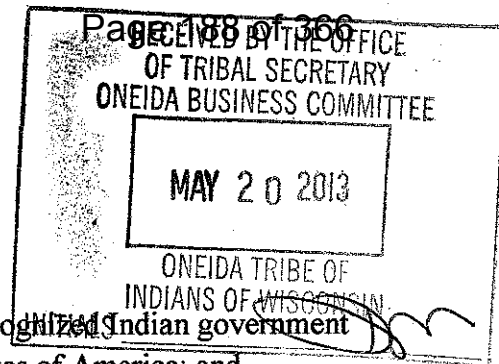

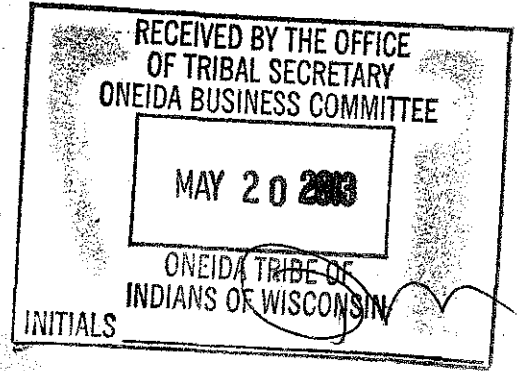
Dissolution of the Second Polling Site



- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States of America; and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin; and
- WHEREAS,** the Oneida General Tribal Council has delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution to the Oneida Business Committee; and
- WHEREAS,** the Oneida Business Committee in 2002 adopted BC Resolution # 3-13-02-O which established a second polling site for Oneida triennial elections in Milwaukee, WI, authorized and directed the Oneida Police Chief to provide two (2) Oneida Police Officers for the second polling site, and approved Fifteen Thousand Dollars (\$15,000) from the General Fund to cover the 2002 triennial election costs; and
- WHEREAS,** the Oneida Police Officers at second polling site are out of their jurisdiction and therefore have no authority; and
- WHEREAS,** the 2005 General Election Final Report indicates 183 persons cast a ballot at the second polling site; and
- WHEREAS,** the 2011 Primary Election Final Report indicates 136 persons cast a ballot at the second polling site with a cost of \$7,519.04; and
- WHEREAS,** the 2011 General Election Final Report indicates 200 persons cast a ballot at the second polling site with a cost of \$6263.19; and
- WHEREAS,** the Oneida Business Committee Resolution #3-13-02-O has not been ratified or endorsed by the General Tribal Council; and
- WHEREAS,** the Oneida Tribe's financial state today has been dramatically diminished since the adoption of BC Resolution # 3-13-02-O; and
- WHEREAS,** the cost of providing an alternative service for the second polling site ^{voters} ~~votes~~ would be more fiscally responsible; and
- NOW THEREFORE BE IT RESOLVED:** the Oneida Election Board be charged with the ^{voters} ~~votes~~ responsibility to develop a plan in order to assist the second polling site ^{voters} ~~votes~~ to have an opportunity to present themselves at the official polling site located within the exterior boundaries of the Oneida Tribe of Indians of WI reservation for triennial elections;

NOW THEREFORE BE IT FINALLY RESOLVED: that BC Resolution #3-13-020 is rescinded in its entirety effective upon the adoption of this GTC Resolution.
