## STATEMENT REGARDING ISSUANCE OF A VARIANCE FOR 112 RIVERDALE DR.

First, I'd like to note that I am not aware of any Public Notice that was made regarding this hearing.

Second, I'd also like to note that this body will have a change of Commissioners later this week so the scheduling of this meeting seems odd.

Clearly this meeting is evidence that Brian Doxtator has been in violation of the Zoning and Shoreland Law by operating Owista Oneida Taxes out of his residence at 112 Riverdale Drive, Oneida, WI, which he has done for at least a decade.

However, it seems that Owista is not the only business that has been illegally operating at Brian Doxtator's residence.

Here is a copy of the contact page found on Friday August 9, 2013 on the website of Strateglobe, LLC, <u>strateglobe.com</u>, which states that Strateglobe's 'Home Office' is located at 112 Riverdale Drive, Oneida, WI.

Here is a copy of Strateglobe's registration with the WI Dept. of Financial Institutions which was filed on January 29, 2007 which lists the registered agent as Joanie Buckley and lists Strateglobe's 'Principal Office. as 112 Riverdale Drive, Oneida, WI.

Strateglobe maintained that 112 Riverdale Drivewas was their office address until their registration was revoked on October 26, 2011.

As you know, Joanie Buckley is currently the Oneida Tribe's Internal Services Division Director.

I live near Brian's residence and I have to say that I've never observed that Joanie Buckley has ever resided at 112 Riverdale Drive.

Yet here is a copy of the Wisconsin Circuit Court Access website's records of a traffic ticket Joanie Buckley received just last year on April 23, 2012 which lists her address as being 112 Riverdale Drive, Oneida, WI.

Here is a list of 'Vendors & Exhibitors' at the 5th Annual Summer Conference held by the Seminole Tribe of Florida on June 4-6, 2013 which lists Strateglobe, LLC, being among them. It lists "Joanie Buckley (Oneida Tribe of Indians of Wisconsin)" as Strateglobe's representative and states that, "Strateglobe, LLC, is a business-consulting firm located on a Native American reservation in Oneida, Wisconsin."

Yet shortly after I mentioned on my blog, <u>OneidaEye.com</u>, that Strateglobe was listing the home address of Brian Doxtator and Owista Oneida Taxes as the address of Strateglobe's 'Home Office' <u>strateglobe.com</u>'s home page changed their address to "P.O. 200, Oneida, WI."

The Brown County's Planning & Land Services online map states that the property in question is held by the United States of America in Trust for Kenneth Hill whom I believe is the grandfather of Attorney William Cornelius who works with Land Commission Chair Amelia Cornelius works at the Oneida Gaming Commission and with whom Amelia's son, Kevin Cornelius, works at Oneida Seven Generations Corporation and other enterprises.

Does Brian Doxtator have a lease for the land in question, and should he continue to be granted that lease given the information I've just outlined?

Does Strateglobe actually have offices on the Oneida Reservation?

Does Joanie Buckley even reside on the Oneida Reservation?

How many other individuals and businesses are illegally claiming that they reside at 112 Riverdale Drive?

It seems possible that Joanie Buckley and Starteglobe may have been illegally claiming 112 Riverdale Drive as her residence and their home office in order to evade taxes.

You should be aware that last week I made all of this information available to the Wisconsin Department of Revenue's Audit Bureau.

Obviously this is disturbing information that this body should consider very seriously before even contemplating the applicant's request, especially given the fact that this body may currently be undergoing a criminal investigation.

Thank you for your time and I have copies of these documents for the Land Commissioners and for those who want copies.
