To Whom It May Concern,

In regard to Case No: 14 CV, Case Code: 30304 – I did have equipment that was used for d/b/a Ultimate Fusion Tumbling Academy and did borrow \$65,000 from Oneida Small Business Incorporated. The capital went into equipment for this facility and is no longer viable.

The business venture did not transpire as had hoped and I understand that and have made an attempt to begin repayment. I have attached the correspondence that I was instructed to send Mr. Gary Jordan and have included emails as well as text messages. There is also a budget that I was required to forward to him and did get that to him on September 19, 2013.

I did voluntarily offer to begin repayment of \$100 a month. At that time Mr Jordan instructed me to hold off as they needed to have an agreement in writing before doing so. After this I received nothing from Mr. Jordan.

I am somewhat confused as to why I have not received any correspondence since last October and then received the paperwork which was served to me on June 11, 2014.

Please advise on what next steps are as I am willing to fulfill my obligation and would like to begin this process as soon as possible.
