**SECURITIES AND EXCHANGE COMMISSION'S
REQUEST FOR CLERK'S ENTRY OF DEFAULT
AGAINST DEFENDANT GREEN BOX NA DETROIT, LLC**

Pursuant to Federal Rule 55(a), the Securities and Exchange Commission respectfully requests the clerk's entry of default against defendant Green Box NA Detroit, LLC ("Green Box Detroit"). The deadline to respond to the Complaint has come and gone, and Green Box Detroit has not responded.

The SEC filed the Complaint in this action on September 19, 2017, and promptly served Green Box Detroit. A process server served Green Box Detroit with a copy of the summons and the Complaint through its registered agent on September 25, 2017. The SEC, in turn, filed a return of service on September 29, 2017. See Dckt. No. 4.

Under Federal Rule 12(a)(1)(A)(i), Green Box Detroit had an obligation to file an answer within 21 days of service of the summons and the Complaint. That is, Green Box needed to file its answer by October 16. That deadline has now passed. Accordingly, the SEC respectfully requests the clerk's entry of default against Green Box Detroit under Federal Rule 55(a).
