This petition outlines violations to the Code of Ethics Law and Oath of Office by Chairman Edward Delgado and seeks removal of Edward Delgado per Removal Law, section 4.4. The Code of Ethics, section 3.6-1(a), allows removal of government officials for violations to the Code of Ethics law. This Petition for removal is based upon the following facts:

Fact 1: Email from Chairman Delgado directing scores to be reconsidered relative to the SEOTS Facility Proposal. Fact 1 is a direct violation of the Code of Ethics section 3.3-3 (a)(1)(2) and 3.3-3 (b)(2)(3).

Fact 2: Email from Diane House dated 5/16/2013, stating chairman's approval to divulge sensitive strategic information to Bonnilake which violates Code of Ethics section 3.3-3 (b)(2)(3) and 3.3-3(d)

Fact 3: Chairman Delgado's continual violations of G.T.C. resolution 2-25-82, 1-17-98, and G.T.C. approved Job Description. Chairman Delgado has directed tribal management positions to act over and above their approved program procedures. The directives by Chairman Delgado violates Code of Ethics law; Section 3.3-3 (a) (1) (2), 3.3-3 (b)(2) and 3.3-3 (c) (1).

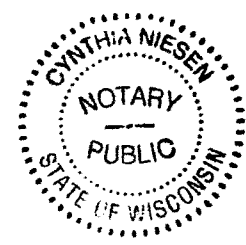
