- 1. That I am an employee of GCF Resources, LLC, a Delaware limited liability company formerly Arland Energy Systems, LLC.
- 2. That I was born on September 17, 1988 and am twenty four years old.
- That my official title is Analyst and my duties include conducting market research, compiling financial documents, and generally assisting the Chief Executive Officer, Louis Stern, with daily clerical tasks.
- 4. That I am not an officer, agent, or manager of Arland Energy Systems, LLC, nor have I ever filled such a role.
- 5. That I am not an employee, officer, agent, or manager of Arland Clean Fuels, LLC, nor have I ever filled such a role.

- 6. That the GCF Resources, LLC office is located in the Chandler's Building at 630 Davis Street, Suite 300, Evanston, IL. The lobby directory lists "Arland Energy Systems" as located on the third floor and the plaque next to the office entry on the third floor lists the company as "Arland Energy."
- 7. That I have reviewed the attached copy of the office floor plan and added descriptions of the floor plan on the attached document titled Exhibit B Floor Plan of Premises.
- 8. That at some point in the day on December 24, 2012, an unidentified individual walked into the offices of Arland Energy Systems, LLC located on the third floor of the 630 Davis Street Building. The sign at the lobby entrance lists Arland Energy Systems, LLC as being located in Suite 300. The sign next to the front door of the office lists the office as Arland Energy.
- 9. That the unidentified individual walked into the office, stopped at point A on the attached floor plan, and asked about the whereabouts of Mr. Eric Decator.
- 10. That I walked over to this individual, meeting him at point A, answering that Mr.
 Decator was not in the office at the time.
- 11. That the individual informed me that we were being served a summons, though he did not specify who "we" meant or what the summons was or related to. This individual flatly stated that someone had to sign for the document.
