Oneida Police Commission:

This letter is in reference to LT. Lisa Drew-Skenandore with the Oneida Police Department. I would like to following items investigated:

- **Wisconsin State Certification** –
  - o Does LT. Drew-Skenandore have this certification?
  - o If not, then how can Chief VanBoxtel allow this when this requirement is required of an entry level Police Officer? How is this justified?
  - o If Not, then I would also assume that she is **NOT** part of the Police Officer's pension, as she does not have the basic requirements needed to even be eligible to be a Patrol Officer. She is **NOT** able to work the road, so should be treated as a civilian. If she is part of the pension, then I would request that this be corrected and retracted from the start date of employment.
- **Money Judgments/Tax Warrants** – LT. Lisa Drew-Skenandore has several Money Judgments against her and her husband, Artley Skenandore. I would hope Chief VanBoxtel would hold the same standard he held against Officer Mark Stanchik when he had the same infraction. Mr. Stanchik was terminated.

LT. Lisa Drew-Skenandore and Artley Skenandore are married and are equally responsible for their finances. They both benefited from their financial endeavors and are **BOTH** responsible for Money Judgments/Tax Warrants.

This is a disgraceful, when the Principle of the Oneida High School and LT. of the Oneida Police Department are being sued for money they misappropriated from the Native American Indigenous Games! It appears that they do embrace the meaning or success of Native American Youth or the Vision of the next Seven Generations.

I would respectfully request that the above concerns be looked into, addressed and handled accordingly. If the Oneida Police Department and Chief VanBoxtel will not adhere to basic fundamental principles, standards and enforce them across the board consistently and fairly, then why have the department? It only allows for low morale, community mistrust and lack of respect for the Chief, Department and Tribe.

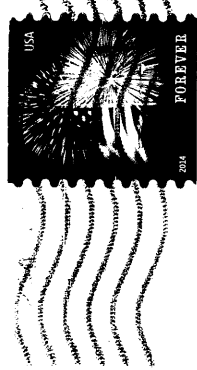
