JOINT MOTION FOR STAY OF PROCEEDINGS

Plaintiffs and Defendant Green Bay Renewable Energy, LLC ("GBRE"), by and through their undersigned counsel, jointly move the Court for an order staying all further proceedings in the above-captioned action pending the resolution of Plaintiffs' appeal (No. 14-3443) to the Appellate Court of Illinois, First Judicial District, of the Court's Order dismissing with prejudice Plaintiffs' Complaint against Defendants Oneida Seven Generations Corporation ("OSGC") and The Oneida Tribe of Indians of Wisconsin (the "Oneida Tribe") for lack of subject matter jurisdiction. The grounds for this stipulated motion are as follows:

1. On October 8, 2014, the Court entered an order granting defendants OSGC and the Oneida Tribe's motion to dismiss for lack of subject matter jurisdiction, dismissing those defendants from this action (the "Dismissal Order"). Also on October 8, 2014, the Court denied, in part, defendant Green Bay Renewable Energy, LLC's motion to dismiss. As a result, claims against defendant Green Bay Renewable Energy, LLC remain pending.

- 2. On October 27, 2014, the Court entered an order granting defendants OSGC and the Oneida Tribe's Motion for Illinois Supreme Court Rule 304(a) Finding and finding no just reason for delaying appeal from the October 8, 2014 Order (the "304(a) Order"). In a separate order, the Court vacated the deadlines for Plaintiffs' to file an amended complaint against GBRE and for GBRE to answer the amended complaint.
- 3. On November 7, 2014, Plaintiffs' filed their Notice of Appeal of the Dismissal Order and the 304(a) Order.
- 4. As the outcome of Plaintiffs' appeal will determine defendant OSGC and Oneida Tribe's participation in the litigation, Plaintiffs and GBRE agree that it will be procedurally efficient to stay all further proceedings in this action pending the resolution of Plaintiffs' appeal.
 - 5. This motion is brought for good cause and not for purposes of delay.

WHEREFORE, Plaintiffs and Defendant Green Bay Renewable Energy, LLC respectfully request the Court to enter an order staying all further proceedings in this action until resolution of Plaintiffs' appeal to the Appellate Court of Illinois, No. 14-3443.
