On Sunday December 2nd, 2012 at 5:58am I, Officer William Cone #819, was on duty in the City of Green Bay, Brown County. Officer Dan House and I were dispatched to 1329 Onu-u-sla Way in the City of Green Bay for a Disturbance complaint.

When I arrived on scene I could hear I could hear a male speaking or yelling loudly at someone while I was approximately 20 feet away from the residence, I could not hear what was being said. I observed the front door of the residence was open and I saw a female sitting in a chair. As I'm walking up to the residence I looked at the female through the glass storm door and I could see a female that was sitting in a chair hunched over holding her stomach with her arms. As I got closer to the residence the female looked out of the glass door and at me. I got within 15 feet of the female and I could see the female was upset and crying. The female appeared as if she didn't want to provoke the male any further and was staying submissive in appearance. I could hear the male speaking loudly at her, I heard him say,

"This is your fault". As I was looking at the female she made a gesture with her hand and waved me into the house. I could see the urgency and fear in her eyes and the tears rolling down her face. Officer Dan House and I continued to walk into the residence.


Once inside the residence I observed a Native American male, approximately 6 feet tall and 200 lbs, standing and pacing in the kitchen over a female that was 5 foot 4 inches and 100 lbs. He was pacing within an area approximately 5-8'from the female. The male subject told the female to "Tell them the truth and not lie". I explained to the male that he was going outside with Officer Dan House and I would be speaking the female without him there.

I spoke with the female, Stephanie L. Stevens (DOB 06-24-82). Stephanie said her husband Ernest went out with his friends at about 5:30 p. m. last night and didn't get home until around 5:50 a. m. this morning. Stephanie said she woke up to the sound of Ernest hitting the front door and yelling. He was calling her a "bitch" and a "cunt" as he was hitting and kicking the front door. Stephanie said she walked to the front door and told Ernest to calm down and then she would open the door. Ernest then kicked the front door two more times and it swung open. Stephanie stated she stepped toward the kitchen table and Ernest stepped toward her, he grabbed her by the shoulders with both of his hands and pushed into the dining table. Stephanie said after a few minutes of screaming at her about not letting him in, Ernest walked back towards the front door, about 8 feet, and picked up a piece of wood from the front door jam that he kicked in and that was lying by the front door. Stephanie said the piece of door jam was about 10 inches long both ends. Ernest then walked back towards her while she was sitting down on a chair in the dining room. Ernest was ranting and raving about her being a "bitch" and said it was over. Stephanie said Ernest wasn't specific about "what was over" but he kept waving the piece of sharp wood about 4-6 inches away from her face. Stephanie advised me Ernest never hit or slapped her but her shoulders did hurt a little when he grabbed her and pushed her into the table.

Stephanie stated she and Ernest have been married for about 6 years and they have two children together. The children were home and sleeping in the bedroom at the time of the incident. I wrote a voluntary statement for Stephanie, she read the statement and signed it. Stephanie stated she did not give Ernest permission to do this to her.

I advised Officer House I had enough for charges on Ernest and he would be arrested. Officer House told me Ernest said he kicked to door in after sleeping in his vehicle for a few hours. Officer House wrote a narrative about his conversation with Ernest.

Officer House Transported Stevens to the Brown County Jail where he was booked in for Domestic-Disorderly Conduct, Damage to Property and Reckless Endangerment. I took 10 photo(s) of the residence, (2) photo(s) were of the piece of wood from the door, (2) photos were of the dining/kitchen area, showing where the female was sitting when I saw her and where the male was pacing. (5) photo(s) was the damage to the residence. I am requesting the following charges to Brown County District Attorney's Office for Ernest L. Stevens. Disorderly Conduct-ss947.01, Reckless Use of Weapon-Endangering Safety-ss941.20(1)(a) and Damage to Property-ss943.01.
