Statement by Madelyn Genskow

Today I attended the meeting of the Oneida Tribal Business Committee. I arrived close to 9 am. I sat towards the front of the Business Committee Conference room. Around 9:30 am, I left the room for a walk to the restroom. I noted that Lou Ann Green and Cathy Metoxen were seated next to each other by the last table inside the room. I also noted that Rocky Hill was standing against the back wall in the room.

Later, I walked to the back of the room again. This time Cathy was not in her seat. I talked to Lou Ann Green. As I was standing next to Lou Ann, I saw Raquel "Rocky" Hill come up and place a folded paper on the table where Cathy had been sitting. I said to Lou Ann, "Rocky is placing a paper next to Cathy's stuff."

At mid-morning, there was a discussion on the Business Committee agenda about concerns regarding the cemetery that is owned by the Oneida Tribe. Cathy Metoxen has a son who is buried there. Cathy was up front speaking at the microphone. She was expressing comments she had heard about people who made statements about all the negative feelings connected to the cemetery.

I decided to go to the back of the room and look at the folded note that Rocky Hill had placed in front of where Cathy had been sitting. I was shocked at what I saw.

It appeared to be a psychic message about a son who was dead and trying to communicate with his mother and the son was desperate. It seemed the intent was to hurt Cathy regarding her dead son.

I took the paper and showed it to Brad Graham, Joyce Hoes, and Beverly Summers. When there was no one in line to speak at the microphone, I addressed the Vice Chair of the Oneida Tribe, Melinda Danforth.

I said "When the Tribal Chair is absent, and you are conducting the meeting, you are responsible for what goes on at this meeting." I made this statement because I wanted an opportunity to report what happened.

I told what had transpired and read the note to everyone who was there. Cathy indicated that she hadn't even noticed the note. The note was extremely upsetting to Cathy because someone had intentionally tried to hurt her.

She said earlier in the meeting that Rocky Hill approached her. Rocky wanted Cathy to go out in the hall. Cathy said Rocky said she had a message from Cathy's son. Cathy said she thought Rocky was talking about her living son. Cathy said she told Rocky that "My son would not send a message through you." Cathy told Rocky to get away from her. The 'Josh' mentioned in the "psychic message" is Cathy's son who died in his 20's.
