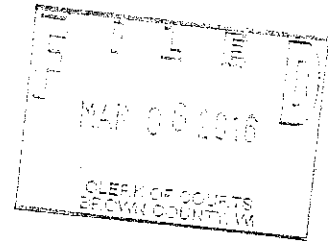

Your Judge Zakowski:

Ronald Van Den Heuvel strongly objects to the proposed order sent to you for your signature on March 2, 2016, this drafted order by Attorney Brittney Ogden on behalf of Cliffton Equities, Inc. is regarding the above encaptioned matter. Ronald Van Den Heuvel has received this order mailed March 3, 2016 and received on March 7, 2016.

The wording of the proposed order seeks to hold Ronald Van Den Heuvel personally in contempt of court on the grounds that Ronald Van Den Heuvel is the "managing member" of Green Box NA Green Bay, LLC.

First of all, Ronald Van Den Heuvel was not personally served in this matter nor was he afforded his right to due process with regard to the contempt order. Ronald Van Den Heuvel was not afforded the ability to contest with immunity, the validity of the claim that he is the company's "managing member" or on other issues brought up in Attorney Brittney Ogden's drafted order. Attorney Brittney Ogden has these records and knows this fact

But more importantly, the company records will show that Ronald Van Den Heuvel has *never* been the "managing member" of Green Box NA Green Bay.


The Company of Green Box NA Green Bay has not certainly been controlled by Mr. Ronald Van Den Heuvel since June 2, 2016. As a result, it would be unjust and completely unfair to hold Ronald Van Den Heuvel personally in contempt as the proposed drafted order seeks to do.

Cliffton Equities could not possibly have put \$650,000.00 toward the thermal Unit #2 for Cliffton Equities did not fund the money for Unit #2 as shown in Exhibit A ,B, C, &D.
