This is written in response to the proposed Order of Contempt and Writ of Bodily Attachment Related to Receiver's Motion ("Order of Contempt") submitted to the Court by Attorney Christopher J Murray in his letter dated March 10, 2015, received March 11<sup>th</sup>, 2016.

As to Paragraph 1 of the Order of Contempt, Ronald Van Den Heuvel is not the managing member of the Defendant Green Box. Green Box filed an accurate list of its assets and liabilities and shall to the best of its ability disclose all assets and liabilities of the company within the time frame of the proposed Order of Contempt. Green Box has a copy of the submitted list.

As to Paragraph 2 of the Order of Contempt, Ronald Van Den Heuvel refused to testify as to certain outside the receivership questions because he was so advised by counsel to assert his right to be free from self- incrimination under the Fifth Amendment of the United States Constitution.

As to Paragraph 3 of the Order of Contempt, it should be amended to provide the full protections afforded to Mr. Van Den Heuvel under Wisconsin Statutes 128.16. Namely, instead of merely stating that he should have "immunity", it should state that he "shall not be liable to criminal prosecution or proceeding for or on account of his testimony".

As to Paragraph 4 of the Order of Contempt, Green Box shall clarify the sublease and the true lessee in due course.
