Brittany S. Ogden, being first duly sworn according to law, deposes and states:

- 1. I am an attorney for Cliffton Equities, Inc. ("Cliffton") and as such familiar with the facts set forth below.
- 2. On February 22, 2016 the Court held a hearing on Cliffton's Motion for Contempt (the "Contempt Hearing"). (Dkt. #14.)
- Counsel for Green Box NA Green Bay LLC was present for the Contempt 3. Hearing.
- 4. At the Contempt Hearing, the Court granted Cliffton's Motion for Contempt and held Green Box NA Green Bay LLC ("Green Box NA Green Bay") and Mr. Ronald H. Van den Heuvel ("Mr. Van den Heuvel") in contempt of Court and required that within 30 days they

either return Cliffton's Kool Unit or post a bond for the sum of \$650,000 in order to purge such contempt.

- 5. On March 2, 2016, I submitted a proposed version of Cliffton's Order of Contempt and Writ for Bodily Attachment to the Court. A true and correct copy of the letter reflecting this submission is attached hereto as Exhibit A. (See Dkt. #10.)
- 6. On March 2, 2016, as indicated by the letter of submission to the Court, I also provided Green Box NA Green Bay and Mr. Van den Heuvel with a copy of Cliffton's proposed Order of Contempt and Writ for Bodily Attachment.
- 7. On or about March 10, 2016, Green Box NA Green Bay and Mr. Van den Heuvel submitted an objection to Cliffton's proposed order. (See Dkt. #9.)
- 8. On March 18, 2016, the Court executed Cliffton's proposed order. A true and correct copy of the Court's executed version of Cliffton's Order of Contempt and Writ for Bodily Attachment is attached hereto as Exhibit B. ("Cliffton's Order of Contempt").
- 9. Pursuant to Paragraph 2 of Cliffton's Order of Contempt, Green Box NA Green Bay and Mr. Van den Heuvel were required to return the Kool-Unit or post a bond in the sum of \$650,000 within 30 days from February 22nd, or in other words, on or before March 23rd, 2016.
- 10. Pursuant to Paragraph 3 of Cliffton's Order of Contempt, should Green Box NA Green Bay and Mr. Van den Heuvel not comply with the terms of Paragraph, Cliffton may submit an Affidavit of Noncompliance and request the arrest of Mr. Van den Heuvel
- 11. On March 25, 2016, our office received Cliffton's Order of Contempt and immediately provided Green Box NA Green Bay and Mr. Van den Heuvel with a copy of Cliffton's Order for Contempt on that same day. As part of this communication, I asked Green Box NA Green Bay and Mr. Van den Heuvel to provide for immediate information regarding

their compliance with the terms of the order. True and correct copies of the email and letter communicating with Green Box NA Green Bay and Mr. Van den Heuvel of Cliffton's Order of Contempt are attached as Exhibit C.

- 12. On March 28, 2016, I spoke with Mr. Van den Heuvel concerning Cliffton's Order of Contempt. During this telephone call I was informed by Mr. Van den Heuvel that no arrangements had been made for the return of the Kool Unit and no bond has been obtained.
- 13. On March 29, 2016, I again asked Mr. Van den Heuvel to provide for compliance with Cliffton's Order of Contempt to avoid our request for his arrest.
- 14. As of the date of the filing of this Affidavit, Mr. Van den Heuvel has not provided me with any other information regarding his compliance with Cliffton's Order of Contempt.

Upon a hearing in the above matter coming on to be heard on February 22, 2016, and appearances of the parties being noted on the record, and in consideration of all pleadings filed and arguments presented; and

WHEREAS, on June 2, 2015, the Court entered an Order Appointing Receiver, Enjoining Creditors from Proceedings Against Green Box NA Green Bay, LLC and Granting Other Relief (the "Receiver Order") on June 2, 2015.

WHEREAS, pursuant to Paragraph 4 of the Receiver Order, Green Box NA Green Bay, LLC, its members, agents, partners, officers and employees were enjoined and restrained from transferring, encumbering or otherwise disposing of any assets of Green Box NA Green Bay, LLC:

WHEREAS, on January 29, 2016, Plaintiff, Cliffton Equities, Inc., filed its Motion for Contempt (Cliffton's Contempt Motion"); it is

ORDERED and ADJUDGED that:

- 1. The Defendant, Green Box NA Green Bay, and its managing member, Ronald H. Van den Heuvel, are in civil contempt of this Court for violating Paragraph 4 of the Receiver Order by transferring, encumbering and otherwise disposing of the assets of receivership estate of Green Box NA Green Bay, LLC and the secured interests of Cliffton Equities, Inc., including one (1) GB Kool Unit, No. 2, also identified by serial numbers 8TKM0630NG03 and 8TKM111414NGO4 (the "2nd Kool Unit"); and
- 2. Ronald H. Van den Heuvel may purge the contempt as against Cliffton by, within thirty (30) days from February 22, 2016, the effective date of this Order, by:
  - a) Returning the 2nd Kool Unit to Green Bay, WI and securing the possession of the 2nd Kool Unit to the Receiver; or
  - b) by posting a bond in the sum of \$650,000 for the value of the 2nd Kool Unit.
- Heuvel to comply with the terms of paragraph 2 above, Cliffton may file with the Court an Affidavit of Noncompliance and providing notice of same to the Defendant Green Box NA Green Bay, LLC and Ronald H. Van den Heuvel by email to Ronald H. Van den Heuvel, and by copying the Receiver and all parties to this action. Upon the filing of an Affidavit of Noncompliance, the Court shall issue an Order of Contempt and Writ of Bodily Attachment to the Brown County Sherriff's Office and upon receipt of the Order of Contempt and Writ of Bodily Attachment, the Brown County Sheriff's Office or any other law enforcement agency able to locate Ronald H. Van den Heuvel shall immediately take Ronald H. Van den Heuvel into custody; and Ronald H. Van den Heuvel shall be brought before the Court within 24 hours of being taken into custody to address said failure to comply with this Order.
