The court is in receipt of correspondence from the parties and has reviewed Mr. VandenHeuvel's letter of March 29, 2016. I had been out of town with my family at that time for spring break before returning to Green Bay this week.


At our motion hearing February 22, 2016, the court granted the contempt motion of Clifton Equities, Inc. The court ordered that Mr. VandenHeuvel could purge that contempt by either returning the Kool unit in question or posting a bond within 30 days from the date of our hearing. The court also ordered that if there was a failure to purge the contempt, Clifton could file with the court and affidavit of noncompliance with appropriate notice. The order also provided that "upon the filing of said affidavit of noncompliance the court shall issue an order of contempt and writ of bodily attachment..."

The court signed the order on March 18, 2016. Mr. VandenHeuvel's correspondence stated his belief that Green Box would be granted thirty days from the issuance of the order to comply with its terms.

The court will withhold signing the writ until April 19, 2016 which is more than thirty days after it formally signed the order. The court does not believe another hearing date is necessary; the contempt hearing has already been held which was the appropriate time to present any evidence.
