# MOTION OF JAIRO HUILAR FOR ALLOWANCE AND PAYMENT OF ADMINISTRATIVE EXPENSE CLAIM PURSUANT TO 11 U.S.C. §503(b)(1)

Jairo Huilar ("Huilar"), by and through his attorneys, Law Firm of Conway, Olejniczak & Jerry, S.C., hereby moves this Court for allowance and payment of an administrative expense claim pursuant to 11 U.S.C. §503(b)(1) of the Bankruptcy Code. In support of this Motion, Huilar represents as follows:

## **JURISDICTION AND VENUE**

- 1. The Court has jurisdiction of this matter pursuant to 28 U.S.C. §§157 and 1334. This is a court proceeding pursuant to 28 U.S.C. §157(b)(2). Venue in this case and over the Motion is proper pursuant to 28 U.S.C. §§1408 and 1409.
- 2. The statutory predicates for the relief requested herein is §\$503(b)(1) of Chapter 11 of Title 11 of the United States Code.

#### **BACKGROUND**

3. On April 27, 2016 (the "Petition Date"), the Debtor filed a Voluntary Petition for Relief under Chapter 11 of the Bankruptcy Code.

- 4. The Debtor continues to operate its business and manage its financial affairs pursuant to §§1107 and 1108 of the Bankruptcy Code.
- 5. Prior to the Petition Date, Huilar entered into a Rental Agreement with Debtor effective July 3, 2013 (the "Lease") on property located at 432 N. Saint Bernard Drive, De Pere, Wisconsin (the "Real Estate"). The initial term of the Lease was one (1) year, but the Lease has continued on month-to-month terms since June 30, 2014.
- 6. Upon information and belief, Debtor allowed its employees to reside on the Real Estate.
  - 7. Debtor has failed to make any rent payments to Huilar since August of 2015.
- 8. On October 6, 2016, this Court granted Huilar relief from the automatic stay to evict the Debtor's employees from the Real Estate.
  - 9. Debtor's employees vacated the Real Estate in October of 2016.
  - 10. Debtor is in arrears of its Lease obligations as follows:

11. By this Motion, Huilar respectfully requests that the Court enter an order allowing

and directing the Debtor to pay Huilar, as an administrative expense, all unpaid rents pursuant to

§§365(d)(3) and 503(b) of the Bankruptcy Code.

WHEREFORE, Huilar respectfully requests that the Court enter an Order providing the

following:

a. Allowing its §503(b)(1) administrative expense claim in the amount of \$11,785.00;

b. Directing payment of Huilar's administrative expense claim immediately upon the

Court's entry of such order pursuant to §§365(d)(3) and 503(b)(1);

c. Granting such other and further relief as the Court deems just and proper.
