MOTION TO OBTAIN SEALED TRANSCRIPT

Now comes the Defendant RONALD H. VAN DEN HEUVEL, by his appellate attorney, Johanna M. Christiansen, and moves this Court for an order allowing counsel to obtain a copy of the sealed transcript of the hearing held on October 26, 2016. In support of this motion, Mr. Van Den Heuvel states as follows:

- 1. On January 5, 2018, this Court held a sentencing hearing in this matter and sentenced Mr. Van Den Heuvel to a term of 36 months in prison, a three year term of supervised release, a special assessment of \$ 100, and restitution of \$ 316,445.47.
- 2. On January 19, 2018, Mr. Van Den Heuvel filed a timely notice of appeal.

- 3. Undersigned counsel was appointed to represent Mr. Van Den Heuvel on February 7, 2018. After receiving the appointment, counsel noted prior defense counsel had ordered most of the relevant transcripts in this matter. However, prior defense counsel had not ordered the transcript from the hearing on October 26, 2016.
- 4. When undersigned counsel attempted to order the October 26, 2016, transcript from the court reporter, the court reporter indicated counsel would have to file a motion requesting this Court allow the court reporter to prepare the transcript and provide it to counsel. The court reporter indicated the transcript would remain sealed if prepared.
- 5. It is imperative that appellate counsel have access to the entire record to appropriately evaluate the case for potential issues on appeal. This includes the sealed transcript. Appellate counsel was not Mr. Van Den Heuvel's attorney in the district court and has no knowledge of the contents of the sealed transcript.
- 6. Counsel believes the transcript should remain under seal at this time.
- 7. Therefore, counsel requests that this Court allow the court reporter to prepare the October 26, 2016, transcript and provide the transcript for counsel to review.

Wherefore, Mr. Van Den Heuvel respectfully requests this Court grant this motion to obtain the sealed transcript.
