Petition for Action on Conditions of Pretrial Release

COMES NOW, Janitza Gomez, U.S. Pretrial Services Officer, presenting an official report upon the conduct of Troy Wragg, who was placed under pretrial release supervision by the Honorable Lynne A. Sitarski sitting in the Court at Philadelphia, on September 17, 2015, under the following conditions:

1. Report as directed to Pretrial Services
2. Submit to random drug testing as directed by Pretrial Services
3. Undergo drug/alcohol treatment if necessary as determined by Pretrial Services,
4. Surrender/Do not obtain a passport
5. Travel restricted to the Eastern District of Pennsylvania and the Northern District of Georgia, unless prior permission is granted by Pretrial Services
6. Surrender/Do not obtain firearms
7. No contact with codefendants, potential witnesses, or other involved in criminal activity
8. Seek/Maintain Employment
9. Maintain residence at 6520 Joe Frank Harris Parkway, Adairsville, GA. If defendant wants to change his address, the defendant must secure permission from Pretrial Services in advance

**On June 28, 2016, Your Honor modified the defendant's conditions of release to include mental health treatment under the direction and guidance of Pretrial Services.**

**On December 4, 2017, Your Honor issued an Order restricting the defendant's travel to the Eastern District of Pennsylvania and the District of Maryland, unless permission is granted by Pretrial Services.**

Respectfully presenting petition for action of Court and for cause as follows:

The defendant is currently being supervised in the District of Maryland, by United States Probation Officer Jessica Weisman. On April 30, 2018, Officer Weisman informed the undersigned that during a psychiatric evaluation on April 17, 2018, the defendant admitted to drinking heavily to help cope with his stress and medical condition. Officer Weisman reported the defendant continues to suffer from seizures, and has been hospitalized on several occasions. Officer Weisman reported the defendant is prescribed medication for his medical issues, adding Mr. Wragg drinks alcohol to cope with his high levels of anxiety, depression, and insomnia.


AUSA Robert Livermore and Defense Counsel, Joseph Mancano, were provided a copy of this petition.

PRAYING THAT THE COURT WILL ORDER the following modification of conditions of release:


1. Defendant shall refrain from the use of alcohol, and submit to alcohol testing as directed by Pretrial Services.
2. Defendant shall refrain from any use of a narcotic drug or other controlled substance, without a prescription by a licensed medical practitioner.
