ORDER TO SHOW CAUSE

16 On July 6, 2018, the Court issued an order setting a hearing for July 19, 2018, at 3:00 p.m.,
17 on Attorney Hector Carbajal's motion to withdraw as counsel for Defendant American
18 Combustion Technologies of California, Inc. ("ACTI"). Docket No. 107. On July 13, 2018, the
19 Court issued an order also setting a hearing for July 19, 2018, at 3:00 p.m., on Attorney James
20 Kawahito's motion to withdraw as counsel, for Defendant ACTI. Docket No. 109. Both orders
21 stated, in relevant part, that: "a corporate representative for Defendant ACTI, and any newly
22 retained counsel shall appear in person" and reminded Defendant ACTI that "corporations may
23 appear in federal court only through licensed counsel." Docket Nos. 107, 109 (internal citations
24 omitted). Each order explicitly warned that "**FAILURE TO COMPLY WITH THIS ORDER**
25 **MAY RESULT IN SANCTIONS.**" *Id.* The record is clear that Defendant ACTI was well aware
26 of these orders. Docket Nos. 117, 119, 120. On July 19, 2018, Defendant ACTI's corporate
27 representative failed to appear, despite the Court's clear orders, at the hearing on its counsels'
28 motions. Docket No. 121.

1 In light of the above, Defendant ACTI is hereby **ORDERED** to show cause in writing, by
2 August 20, 2018, why the Court should not issue sanctions against it for violating Court orders, up
3 to and including a Court fine of up to \$500 and/or case-dispositive sanctions. *See* Fed.R.Civ.P.
4 16(f); *see also* Local Rule IA 11-8.

5 **Failure to respond to this order will result in a recommendation that judgment be**
6 **entered against Defendant ACTI.** The Clerk's Office shall promptly provide notice of this order
7 to Defendant ACTI at:
