IT IS HEREBY ORDERED, ADJUDGED, and DECREED that:

On October 23, 2018, as a result of Defendant American Combustion
 Technologies of California, Inc.'s ("ACTI") failure to respond to multiple show cause orders
 [see ECF Nos. 126 & 127], United States Magistrate Judge Nancy J. Koppe entered a Report and
 Recommendation [ECF No. 128] recommending that default judgment be entered against ACTI.

2. On November 15, 2018, United States District Judge James C. Mahan entered an order adopting Magistrate Judge Koppe's Report and Recommendation in its entirety and entering default judgement against ACTI. [ECF No. 129]. The Court instructed the clerk of the court to enter default judgment accordingly. [*Id.* at 2:13].

3. On November 15, 2018, the clerk of court entered default judgment in favor of CH2E and against ACTI. [ECF No. 130].

4. On December 19, 2018, CH2E filed a motion under Fed. R. Civ. P. 55(b) for the entry of default judgment against ACTI for proven damages. [ECF No. 131].

¹⁵ 5. On March 29, 2019, the Court entered an Order granting the entry of default
¹⁶ judgment against ACTI and calculating CH2E's damages pursuant to Fed. R. Civ. P. 55(b). [ECF
¹⁷ No. 132]. Specifically, the Court found that CH2E was damaged in the amount of
¹⁸ \$11,885,669.91. [*Id.* at 3:10-11].

For the above stated reasons, and for the reasons stated in the Court's Orders
granting CH2E's motion for default judgment [ECF Nos. 128-130] and calculating damages in
CH2E's favor pursuant to Fed. R. Civ. P. 55(b) [ECF No. 132], Judgment is entered in favor of
Plaintiff CH2E Nevada LLC, and against Defendant American Combustion Technologies of
California, Inc., in the amount of \$11,885,669.91, with interest continuing to accrue at the
applicable legal rate.

7. This Judgment incorporates by reference all factual findings and conclusions of
law set forth in the Court's Orders granting CH2E's motion for default judgment [ECF Nos. 128130] and calculating damages in CH2E's favor pursuant to Fed. R. Civ. P. 55(b) [ECF No. 132].
