## DEFENDANT'S MOTION FOR MODIFICATION OF BAIL

## ALEJANDRO LOPEZ, Defendant

Alejandro Lopez, by counsel, hereby respectfully requests a review of the Court's decision to detain the Defendant and deny her bond.

AS GROUNDS, THE DEFENDANT ASSERTS:

- 1. On 25 Sep 2019 the court ordered that Lopez be detained on presumption.
- 2. This is Nash's first motion to modify bail since that date.
- 3. The State case was dismissed (see attachment)
- 4. A magistrate judge may detain the defendant only if there is no set of release conditions under 18 U.S.C. § 3142(b) that will reasonable secure the safety of the community or that will reasonably assure the defendant's appearance at trial. Although the charges that Nash faces create a presumption of detention, the presumption may be rebutted by "[a]ny evidence favorable to a defendant" that bears on any one of the factors in § 3142(g)."
- 5. The Defendant is a longtime resident of Northeastern Wisconsin (> 20 years).
- 6. The Defendant has a limited criminal background with his most recent conviction occurring in 2004 for misdemeanor Battery.
- 7. The original bond study filed 18 Sep 2019 provides "There may be conditions of release should he have a viable home plan and the social information is verified."
- 8. His extended family is also in the Brown County area.
- 9. Defendant has remained in close contact with his counsel.
- 10. If Lopez is released on bond, he has identified the following places he could reside:

- 11. When Lopez was arrested for these charges, he was employed at Griffin Industries. Thus, Lopez has demonstrated an employment history, which makes it likely that, if released, he could become employed again. (see attachment)
- 12. There are other non-monetary conditions of release that can help assure the Defendant's appearance in Court. The following conditions are sufficient to protect the community:
  - a. Lopez's travel shall be restricted to the Eastern District of Wisconsin;
  - b. Lopez shall not possess any firearms or other dangerous weapons;
  - c. Lopez shall have no contact with codefendants or witnesses in this matter;
  - d. Lopez shall remain at home during prescribed times in accordance with one of three program components (curfew, home detention and home incarceration) and electronic monitoring.
  - e. Lopez shall participate in a program of testing and treatment for drug and alcohol abuse as approved by Pretrial Services.
  - f. Lopez shall seek employment, volunteer work, and/or education opportunities;
  - g. Lopez shall not use or possess controlled substances except according to a physician's prescription.
- 13. The Defendant has been drug-free for nearly two (2) months and is an excellent candidate for treatment now that he is clean.
- 14. The Defendant has the ability to seek treatment while out of custody.
- 15. The Defendant is willing to have his location being monitored electronically and willing to be closely supervised.

Wherefore, it is respectfully requested that the court hold a detention hearing to consider evidence supporting this motion and to amend the detention order entered in this matter to allow for Lopez's release upon conditions set by the court. Dated this 2 Oct 2019
