

Statements & Truths

- The DOJ does not live in the Ron Van Den Heuvel (RVDH) community. DOJ personnel live 128 miles away in Milwaukee. Please ask them to STOP not telling the whole truth within the Federal Justice System. And to the Honorable Judge William Greisbach. Please see and correct these statements. DOJ and agents have given Oneida Eye Private information essentially daily.

1. RVDH does not have the Covid-19 virus at this time!

Truth - RVDH has never been tested for Covid-19. The truth is less than 25% of the inmates & Correction employees have been tested at Duluth Federal Prison Camp (DPC). This is a great way to not know what's happening. Previously I was told by your Honor that Duluth Federal Prison Camp must be doing a good job because they have no Covid-19 cases. Well that is no longer the case. **Right now there are at least 12 cases with these inmates housed in the temporary hospital** located in the campus gymnasium. In addition, the BOP has now quarantined 2 of our dorms, 211 & 207. This means all inmates within are not allowed to leave their facility. All food is brought to them.

We are down to possibly less than 300 men here and Covid is now running rampant on our Duluth Prison Camp grounds. There could be many more that have Covid and we don't or won't even know it.

Supposedly, they are bringing in 20 more inmates this week all of which will NOT have been tested.

On March 26, 2020, Attorney General William Barr directed the BOP To identify and release inmates to home confinement if they have Covid-19 risk factors.

I am at an extreme level of high risk and the virus is running rampant at our Duluth camp.

2. My wife Kelly sends in American Diabetes Association (ADA) medical information for facilities that detain people.

Truth - Elderly over 65 with diabetes, the ADA recommends they avoid crowds (over 80 men) and poorly ventilated spaces. There is no ventilation in my Dorm, Dorm 208. In any big city RVDH, age 66, would be relocated from his high humidity and temperature area. BOP stated Dorm 208 has ventilation, wrong (zero) only a window with no ventilation.

Sheets and blankets stick to RVDH's body. This condition along with RVDH's DKA makes managing sepsis very difficult. Covid-19 quarantine restriction @ DPC make these health concerns cause congestion and RVDH on hot & humid nights must sleep sitting up.

3. RVDH walks when put on wheelchair confinement/convalescence. RVDH's dorm 208 with 80 other men does not have wheelchair access. BOP states incorrectly that all 4 dorms have wheelchair access.

Truth - Dorms 209, 210 & 211 have wheelchair access and Dorm 208 has none. RVDH's Room 119 is over 108 feet from the only allowed entrance therefore REVH was told to heel-walk every day (8 times) 864 feet every day and night bathroom.

4. RVDH is only a Care Level 3 inmate because he has an amputated big toe on his left foot and he is diabetic. RVDH had to have a big toe amputated due to uncontrolled diabetes.

Truth - RVDH is Care Level 3 because Honorable Judge William Greisbach ordered DOJ to get BOP to understand RVDH's disease of

on-set auto-immune Type 1 Diabetes and give adequate care. This disease has genetic triggers - my father had it.

The BOP allowed RVDH's wife to bring in his two type Insulin pens and RVDH could receive 6 to 8 shots/day as he received at Home Care and at Home while in BOP custody. RVDH is Care Level 3 due to a high level of hypertension in his bloodstream & lungs. RVDH has lost his hearing. Hypertension has caused RVDH to lose 5 teeth and needs 4 root canal surgeries due to infections. RVDH cannot control his blood sugars with only two shots/day. In addition, RVDH has neck blockage & dizziness.

5. "RVDH was told on the first meeting with Dr. Rice that he could be transferred to a Care Level 3 BOP facility."

Truth - RVDH is the **worst diabetic @ DPC in the last 2 years.**

RVDH takes over 111 ML of insulin in two doses which are given only twice per day. This causes huge blood sugar swings. RVDH can not receive adequate medical care @ the Care Level 2 Duluth Prison camp. This inadequate care does not allow enough doses of insulin and this causes Kidney pains. - Daily High Blood Sugars of 407.

Normal is between 70 - 120. My A1C level is 9.6 - very, very high.

I am a hugely **HIGH RISK**

Truth - RVDH is only diabetic over 65 left in DPC out of 18 elderly when RVDH first arrived. All others have been released by a judge or the BOP.

6. RVDH does not follow his diet. He was told by Judicial System of the BOP - DPC. Dr. Rice also stated losing teeth is only a dental problem.

Truth - Dr. Rice reviews RVDH's purchases at commissary, our food store, which is fine. However, Dr. Rice has no idea what RVDH eats or how he is allowed to exercise. RVDH buys commissary items for the poor, indigent, Christian Prayer Groups, Catholic Mass Groups &

other groups. RVDH does not eat 10 candy bars (zero). Not a dental problem, it's because of a lack of blood flow due to hypertension. This is the cause of tooth loss.

7. DOJ says RVDH is a "danger to the community" which was told to the Judicial System and to the Honorable Judge William Greisbach in a response to RVDH's Compassionate Release request.

Truth - Upon release RVDH can work in Michigan, a 3 hour drive from Green Bay, for 3 years at \$80.00/hour with a royalty and begin to pay his restitution. And in this county in Michigan there are **no known Covid cases** to the best of my knowledge

RVDH has given his time & support & dollars to our greater Green Bay Community averaging about \$920,000/year (see tax returns) over the last 38 years. RVDH has received 470 letters of support with only 2 being negative. Chinese EB-5 parties that are going to be US Citizens must be repaid.

56 people in court at sentencing only two against, Brazilian EB-5 doctor Marco Araujo (now US citizen) his Nurse girlfriend. Marco & Claudia moved family to school in Dallas, TX.
Clifton Group that came to Green Box through company officers from Canada. All foreign investors will be repaid. All are personally Guaranteed notes.

Community 20 year + friends Dave Williquette & Dr. Eddie Lin were partners in Green Boxes Packer Box. Dr. Lin put braces on RVDH's children after charges.

RVDH has received over \$29 million dollars of grants and tax exempt bonds and training funds and has repaid all monies back except for \$1,100,000 of WEDC which is first restitution to be repaid. Government states RVDH may have damaged US-China relationship, they must be

joking! China stole Green Box 100% Reclamation of food contaminated waste to tissue & biofuels technology. Signed papers with AIC-Asia Investment Corp which shows they owe \$20 million dollars. - They have built 5 units, and the US State Department is helping recoup.

In the USA over 1,730 jobs have been created and are still operating. RVDH loves the Greater Green Bay community area and citizens. No party will ever be hurt by RVDH. RVDH has an \$80.00/hour design job and royalties from equipment sales and Social Security to pay back the things done wrong.

38 months is RVDH's 50% served. Now I have 34 done.

RVDH has read the entire CARES ACT. No where does the CARES ACT state that a vulnerable inmate non-violent must serve x amount of time. I'm a 66 year old vulnerable inmate with two minor children, 9 grandchildren and a great-grandson. They need RVDH to visit with & help with Home Schooling. (Protected Quarantine). His adult children & inlaws need him also. Covid-19 has taken away visits for approximately the last 7 months that no one talks about but are very critical.

RVDH needs to sell assets to pay all his restitution as soon as possible. RVDH has finalized patents and kept all licenses (56) up. RVDH worked 90 hour weeks for 11 years to patent 100% Sanitation and 100% Reclamation of the World's food contaminated waste stream to tissue and Biofuel products with zero wastewater discharge, zero landfilling, zero incineration & requiring no third party utilities.

The World needs this Sanitation & Reclamation patented system right now, TODAY! Over 11 large corporations continue to ask for the patents to use, but need RVDH's help.

RVDH has been severely punished -- Google RVDH!


