**MOTION FOR ENTRY OF PRELIMINARY ORDER OF FORFEITURE**

The United States of America, by its attorneys, Richard G. Frohling, Acting United States Attorney for the Eastern District of Wisconsin, and William J. Roach, Assistant United States Attorney for said District, hereby moves this Court pursuant to Rule 32.2 of the Federal Rules of Criminal Procedure for an order forfeiting to the United States all right, title and interest in the approximately \$2,261.00<sup>1</sup> in U.S. currency seized on August 2, 2019, from Richard D. Guyette, described in the Superseding Indictment filed on September 10, 2019.

This motion is based on the provisions of Title 21, United States Code, Section 853 and on all proceedings of record in this case. In particular, defendant Richard D. Guyette pled guilty to Count One of the Superseding Indictment, and pursuant to his plea agreement, agreed to the forfeiture of the property items listed in the forfeiture notice of the Superseding Indictment.

No affidavit or memorandum is submitted in support of this motion.

**PRELIMINARY ORDER OF FORFEITURE**

Upon the motion of the United States of America pursuant to Rule 32.2 of the Federal Rules of Criminal Procedure, and upon the entry of the plea agreement, and in consideration of the guilty plea of defendant Richard D. Guyette to Count One of the Superseding Indictment filed on September 10, 2019, defendant Richard D. Guyette agrees to the forfeiture of the property item listed in the forfeiture notice of the Superseding Indictment filed on September 10, 2019.

IT IS HEREBY ORDERED that all right, title, and interest in the approximately \$2,261.00 in U.S. currency seized on August 2, 2019, from Richard D. Guyette, is hereby forfeited to the United States pursuant to Title 21, United States Code, Section 853.

IT IS FURTHER ORDERED that the above-listed item shall be seized by the United States Marshal Service for the Eastern District of Wisconsin, or its duly authorized representative.

IT IS FURTHER ORDERED that pursuant to Title 21, United States Code, Section 853(n)(1) the United States shall publish notice of this order and of its intent to dispose of the property according to law.

IT IS FURTHER ORDERED that the terms of this Order shall be recounted in the defendant's Judgment and Commitment Order.
