MOTION FOR CLARITY / CORRECTION

OF IMPOSED SENTENCE

Now Comes Defendant Ronald H. Van Den Huevel, Pro Se, before this Honorable Court, at the direction of the Department of Justice / Bureau of Prisons, seeking corrections to be made within the sentry system.

HISTORY

Defendant, born [REDACTED] 1954, was "sentenced to 36 months in prison on January 15, 2018. On January 23, 2019, Van Den Heuvel was sentenced to a concurrent term of 90 months for Wire Fraud" (Direct quote from Order filed 02/08/21, Page 1 of 4, Document 255). Today the Department of Justice / Bureau of Prisons has information in their system to the contrary. It is at their direction Defendant brings forth this motion to correct the following errors:

- (1) Date of birth: [REDACTED] 54 - Correction [REDACTED] 16, 1954
- (2) Date of sentencing: 01-05-2018 - Correction January 15, 2018
- (3) Term of sentence: 8 years, 17 days - Correction 90 months

Confirmation of the above errors, as reported in the system, are attached as Exhibits A & B.

The above information, including the Bureau of Prisons reporting Defendant is serving an "8 year and 17 days" (96+ months) sentence, is causing Defendant to have an incorrect accrual of sentence completed. This incorrect information is causing Defendant harm as the Bureau of Prisons continues to incorrectly calculate his percentage of sentence and Good Credit Time. These errors, if left uncorrected will cause defendant to spend more time incarcerated as it currently delaying Defendant from qualifying for release to home confinement under the CARES ACT - administered via the Bureau of Prisons. Currently a 2241 action would not be appropriate.

PRAYER OF RELIEF

Defendant asks for an Order to clarify / reaffirm this Courts prior Orders and for the Bureau of Prisons to implement such as initially Ordered.
