## ORDER SCHEDULING TELEPHONIC STATUS CONFERENCE ON PLAINTIFFS' MOTION FOR A TEMPORARY RESTRAINING ORDER

Sertant Capital, LLC and Prime Alliance Bank, Inc. sued the Great Lakes Tissue Company for breach of contract, conversion, and claim and delivery. (ECF No. 1, PageID.2–3, 14.) Sertant and PAB allege that GLT materially breached a lease agreement whereby GLT agreed to lease certain equipment and personal property from Sertant for about \$68,000 per month. (Id. at PageID.7-8.) To protect their equipment and property more expeditiously, Plaintiffs filed a verified motion for possession pending final judgment and requested that the Court enter an ex parte temporary restraining order against GLT pursuant to Michigan Court Rule § 3.105(E)(2). (ECF No. 4.)

On March 18, the Court denied Plaintiffs' motion for an ex parte temporary restraining order for failure to adhere to Federal Rule of Civil Procedure 65(b) and scheduled a hearing on the Plaintiffs' motion for immediate possession pending final

judgment for April 17, 2023. (ECF No. 9, PageID.160.) The Court later directed Plaintiffs to re-serve GLT consistent with the Federal Rules of Civil Procedure. (ECF No. 12.)

Today, Plaintiffs filed a renewed motion for a temporary restraining order again asking the Court to restrain GLT from damaging or destroying its property pursuant to Michigan Court Rule § 3.105(E)(2). (ECF No. 19, PageID.185.) Plaintiffs' attorney also filed a declaration noting extensive efforts undertaken to properly identify, contact, and serve GLT and its counsel. (ECF No. 20.) in fact, the declaration identifies several attorneys contacted by Plaintiffs that may, in some capacity, represent GLT. (ECF No. 20, PageID.201.)

Having reviewed the filing and Plaintiffs' efforts over the past few weeks to notify and involve GLT, the Court hereby schedules a telephonic status conference, for all parties, on Plaintiffs' motion for a temporary restraining order for **Tuesday**, **April 4, 2023, at 9:00 am**<sup>1</sup>. Plaintiffs are further ordered to immediately serve this notice via email to all GLT affiliated attorneys referenced in the declaration attached to their motion.
