

STATE OF WISCONSIN - VS - Lolihwakaya Hill

Complainant is an Assistant District Attorney with the Brown County District Attorney's Office and knows of the above offense(s) on information and belief based upon:

PROBABLE CAUSE:

The complainant, being duly sworn on oath, swears that he has had the opportunity to review the police reports from Officer Berglund and Officer Doepke of the Green Bay Police Department, and other documents supporting this complaint referenced herein, which are the types of reports and documents kept in the ordinary course of business, which complainant believes to be truthful and reliable because they have proven to be truthful and reliable on numerous occasions in the past.

The complainant further asserts that based upon his review of the referenced reports and/or supporting documents, the incidents alleged occurred in Green Bay, Brown County, Wisconsin.

1. Complainant has reviewed the reports of School Resource Officer Berglund, which state, in part:

"On Monday November 14th, 2022, I, (SRO Berglund) was called to the main office of Kennedy Elementary School to speak with a student who had marks on his neck and was stating that his father choked him last night. I was also informed CPS was on scene as well.

I made contact with CPS worker Roselynn Griesbach and Oneida CPS worker Sara Shahin-Kesti in the main office. They informed me that LD (an 8 yr old male child) was in the office a few minutes earlier and he showed marks on his neck and stated that his father Lolihwakayu (NMI) Hill (06/14/1987) (Loli) had choked him.

When LD come to the office I asked him if he had marks on his neck. He showed me his neck and I could see a mark on his neck which was consistent with thumbs pushing on the front part of his neck like he described. LD also showed me the back of his neck and he had marks on the back of his neck as well. LD said he was facing Lolihwakayu when he was being choked and Loli had his thumbs on the front part of his neck and his hands wrapped behind his neck. LD told me he got into an argument with Lolihwakayu, and he could not remember what it was about. LD said Loli choked him at one point in the argument and that is all he remembered.

On Tuesday, November 15, 2022, I went to the Child Advocacy Center located at 503 S. Monroe Rd for the forensic interviews of LH (the 6 yr old sister of LD) and LD. I met Case Manager Kelsey Keast and Rosalynn in the room to witness the interview as well. We met with Child Forensic Interviewer Kristie Sickel and talked about the case.

Sickel asked LH about her family and had her explain who is staying with them at her grandma's house. Sickel went through LH's family and then asked if they were staying some place else before they went to grandma's and had her talk about her dad and LH said Loli. LH said shew as staying with her dad before they went to her grandma's house and explained who lived with her at her dad's. Sickel asked LH to tell her all about staying at her grandma 's house

and not her dad's house and LH said she said she had to go to a doctor's appointment and that is why she is here. Sickel told LH that she talks to kids about something that happened to them and asked if anything happened to her, and LH said she gets mad and said and explained when someone comes to her and says a mean word it makes her mad. Sickel asked if something happened to LD recently and LH said he thought she was lying when he had glitter on his body and blamed LH, but LD did it to himself. Sickel asked LH about her little sister and if anything happened to her and LH explained she helps her when she gets hurt. Sickel told LH she wanted to learn about living at her dad's house how does he take care of you. LH replied when she gets hurt her dad takes care of her by getting a band aid. LH explained her dad puts healing medicine on them when they get scratches. Sickel asked about rules at her dad's house and LH explained they have jobs like vacuuming and cleaning. Sickel went through getting hurt at her dad's and asked if her sister gets hurt at her dad's and LH went through what happens. Sickel asked about LD getting hurt. Sickel asked LH If there was ever a time when she saw someone hurt LD and LH said, "My dad. " Sickel asked LH to explain how her dad hurt LD and LH said, "He choked LD. " Sickel asked a follow up with LH about how she knew her dad choked LD, and LH said she saw her dad. Sickel told LH to tell her everything she saw how that happened and LH said he choked him the first day and then pushed LD and then LD stepped on her hand. LH explained a time when her dad pushed LD, and he tripped over her and scratched her arm. Sickel went over the incident with LH and then asked what her dad's name that was did this to LD and LH replied, "Loli. " Sickel asked LH where she was that she saw this happen and LH said LD, and her dad were by the bathroom door when her dad was choking LD and LH said she was hiding behind a mirror in the living room and she was hiding so her dad could not see her. Sickel went through the incident and asked LH what her dad used to choke LD and asked when her dad was by the bathroom door what was her dad doing. LH explained. Sickel asked what happened to LD when her dad was choking him, and LH answered. Sickel went back and asked LH what her dad used to choke LD, and LH replied, "his hand."

Sickel got the room ready for the interview with LD at approximately 2:09pm and went in the room and made an announcement. Sickel left the room and then came back in with LD. Sickel went over the cameras and the microphone with LD. Sickel explained there were people in another room watching them today. Sickel went over the board in the room and then had LD talk about himself and what he liked to do for fun. LD talked about his cousins and a time they went to Alabama. Sickel had LD talk about school and what he did at school today. LD explained Gaga ball and how they play the game at school. Sickel explained she wanted LD to correct him if she got something wrong. Sickel went through a scenario with him so he could correct her. Sickel explained she wants LD to say he does not know if he doesn't know an answer and not to guess. Sickel went through a few scenarios with LD. Sickel went through truth and lies and had LD talk about things that are true. Sickel went through a couple pictures of a boy and a girl telling the truth and a lie. Sickel went through recess with LD and had him explain recess from the start to the finish. LD talked about playing Gaga Ball with his friends. Sickel had LD talk about how he went in from recess and everything he did. Sickel explained to LD how she would ask questions like she did when he was talking and pointed it out as he was talking about recess. Sickel told LD she wanted to talk about his family and said how he was living with his grandma and asked where he was living before, he went to her house. LD said he was living at her house. Sickel had LD talk about his family and LD talked about how they live with his grandma because they have to stay safe because his dad was choking him. Sickel said she wanted to learn about how LD's dad choked him and LD explained how his dad was talking to him and then walked closer to him and then ran at him and jumped on him and

started choking him. LD said his dad has his thumbs on him and LD said OK and then his dad got off. LD said his dad was choking him and told him he needed to listen, and he said OK. Sickel asked where he was when his dad was choking him, and he said he was at his house and Sickel asked where in the house he was and LD said his room. LD said they were on his bed, and he was laying down when he was being choked. Sickel said she wanted to learn about how his dad was talking to him and LD said his dad told him he needed to listen more and then started choking him. LD said his dad ran at him and jumped on top of him and started choking him. Sickel asked questions about how his dad's body was when he was choking LD and LD said he hopped on him and was yelling at him and then started choking him. Sickel asked about dad's body when he hopped on LD and LD said it was strong and that he was scared. Sickel asked what the next thing his dad did after he hopped on LD and LD explained his dad hit him in the head with his head and then screamed in his ear. Sickel had LD to explain when his dad started to choke him and asked if it was before he hit him in the head and asked what his dad was using to choke him and LD used his hands to describe how his dad's fingers were in the middle of his neck. Sickel had LD explain what was happened when his dad 's finger was on his neck and LD said he couldn't breathe. Sickel asked LD to tell her more and he said he felt like he was going to pass out. LD said his dad 's fingers were on his neck and then he let go before he passed out and then left and came back and told him he could get up now. Sickel asked LD what he felt when he couldn't breathe and LD said he was scared. Sickel asked what his face looked like when he was choking and LD said his dad's face looked like melting. Sickel asked LD what he could see with his eyes when his dad's hands were on his neck and LD said he could see, "Dark stars." Sickel had LD tell him more and he said they were black. Sickel told LD to tell her about when his dad got off him and LD said he felt sad and wanted to go to his grandma's house. LD said he did not feel safe when his dad's body was on top of him. Sickel had LD explained where his hands were and LD said they were on his neck. Sickel had LD go over the incident again and LD did and said his dad told him to just listen next time. Sickel asked if his dad said anything about the incident and LD said his dad hasn't and hasn't even said sorry. LD said he felt like his dad was a killer and he was trying to kill him."

2. Complainant has reviewed the report of Ofc. Doepke, which states, in part:

"On 11-15-2022, I Officer Doepke, was assigned to full uniformed patrol in the City of Green Bay as 2A3. At approximately 15:00 hours, I was dispatched to assist School Resource Officer (SRO) Berglund at 1815 9th St, Apt# 33 reference this case. Upon arrival, SRO Berglund informed me that a male identified as Lolihwakayu (NMI) Hill (DOB 06-14-1987) was wanted for his arrest for charges of suffocation and strangulation, and physical abuse of a child-intentionally cause bodily harm.

SRO Berglund, Officer Eick, and I walked to the apartment and SRO Berglund knocked on the door. Lolihwakayu answered the door and allowed Officers to enter his apartment. Once inside, SRO Berglund spoke to Lolihwakayu and informed him that he would be taken into custody. Officers allowed Lolihwakayu to grab shoes, a jacket, and to use the bathroom. I overheard SRO Berglund informed Lolihwakayu that he would be going to Jail today. Lolihwakayu turned around towards SRO Berglund with his hands behind his back, so I placed him into handcuffs behind his back which were checked for fit and safety locked."

Your complainant has reviewed the records of the Wisconsin Circuit Court Access Program (CCAP) website, which records are believed to be truthful and reliable as they are records kept

in the ordinary course of departmental business. Said records indicate that on the above date of offense, the defendant had been previously released on bond in open and pending Brown County Misdemeanor Case 22CT961. A standard condition of that bond is that the defendant commit no new crime.

Based on the foregoing, the complainant believes this complaint to be true and correct.
