Complainant, William C. Griesbach, being first duly sworn, on oath deposes and says that on or about May 20, 1995 in the Town of Hobart in Brown County, State of Wisconsin, the defendant did:

have sexual contact with a person who has not attained the age of 13 years, to-wit: ENC, DOB 12-10-82; FIRST DEGREE SEXUAL ASSAULT OF A CHILD-Felony, contrary to Section 948.02(1), Wisconsin Statutes.

The offense is defined as a Class B Felony; upon conviction of the offense, the defendant is subject to imprisonment of not more than 40 years.



that the basis for the complainant's charge of such offense is:

Complainant is an Assistant District Attorney with the Brown County District Attorney's Office and knows of the above offense on information and belief based upon:


1. His review of a signed written statement given by a 12 year old juvenile whose initials are ENC and whose date of birth is 12-10-82; ENC states that on May 20, 1995 she was behind a house on Artley Street in the Town of Hobart, Brown County, Wisconsin, when the defendant herein called her over to a picnic table. ENC states that the defendant had been drinking and he grabbed her by the arms and pinned them on the picnic table; she was facing the table and her hands were crossed on the table and the defendant held them with one hand. The defendant was sitting down in front of her and then unbuttoned ENC's pants and placed his fingers down insider her underwear; he touched her in the area of her vagina and then pulled his hand out; he then asked ENC if she liked or loved him and said if you don't, just leave; she then went to a friend's house on Artley Street and told what had occurred; ENC further states that she told the defendant she was turning 13 years old and at no time gave him permission to touch her in the area of her vagina.

2) The report of Officer Owen Somers of the Oneida Police Department, wherein Officer Somers indicates he spoke with the defendant following the report received from ENC. He asked the defendant if he had touched ENC and he stated he had held her around the waist and kissed her. He stated that he did not put his hands under her clothing. Officer Somers further states that the defendant appeared to be intoxicated and had been drinking beer.
