Complainant, Jessica R. Petras, a Special Prosecutor, being first duly sworn on oath, deposes and says that:

Count 1: REPEATED ACTS OF SEXUAL ASSAULT OF A CHILD, REPEATER

The above-named defendant on or between Thursday, June 1, 2017, and Friday, September 1, 2017, in the Village of Hobart, Brown County, Wisconsin, did commit repeated sexual assaults, <u>specifically involving anal intercourse</u>, involving the same child, AGS, an eight-year-old child, where at least three of the assaults were violations of sec. 948.02(1)(am), (b) or (c) Wis. Stats., contrary to sec. 948.025(1)(b), 939.62(1)(c) Wis. Stats., a Class B Felony, and upon conviction may be sentenced to a term of imprisonment not to exceed sixty (60) years.

And further, invoking the provisions of sec. 939.62(1)(c) Wis. Stats., because the defendant is a repeater, having been convicted of Possession of THC in Brown County Case Number 18CM1184 on or about August 20, 2019 and Possess Drug Paraphernalia and Bail Jumping in Shawano County Case Number 18CM457 on or about July 30, 2019, which conviction(s) remain of record and unreversed, the maximum term of imprisonment for the underlying crime may be increased 2 years if the prior convictions were for misdemeanors.

And furthermore, invoking the provisions of Wisconsin Statutes 939.616(1r) and (3), the defendant being 18 years of age or older at the time of the offense, the court shall impose a bifurcated sentence under s. 973.01. The term of the confinement in prison portion of the bifurcated sentence shall be at least 25 years. Otherwise the penalties for the crime apply, subject to any applicable penalty enhancement.

Count 2: REPEATED ACTS OF SEXUAL ASSAULT OF A CHILD, REPEATER

The above-named defendant on or between Thursday, June 1, 2017, and Friday, September 1, 2017, in the Village of Hobart, Brown County, Wisconsin, did commit repeated sexual

assaults, <u>specifically involving oral intercourse</u>, involving the same child, AGS, a n eight-yearold old child, where at least three of the assaults were violations of sec. 948.02(1)(am), (b) or (c) Wis. Stats., contrary to sec. 948.025(1)(b), 939.62(1)(c) Wis. Stats., a Class B Felony, and upon conviction may be sentenced to a term of imprisonment not to exceed sixty (60) years.

And further, invoking the provisions of sec. 939.62(1)(c) Wis. Stats., because the defendant is a repeater, having been convicted of Possession of THC in Brown County Case Number 18CM1184 on or about August 20, 2019 and Possess Drug Paraphernalia and Bail Jumping in Shawano County Case Number 18CM457 on or about July 30, 2019, which conviction(s) remain of record and unreversed, the maximum term of imprisonment for the underlying crime may be increased 2 years if the prior convictions were for misdemeanors.

And furthermore, invoking the provisions of Wisconsin Statutes 939.616(1r) and (3), the defendant being 18 years of age or older at the time of the offense, the court shall impose a bifurcated sentence under s. 973.01. The term of the confinement in prison portion of the bifurcated sentence shall be at least 25 years. Otherwise the penalties for the crime apply, subject to any applicable penalty enhancement.

Count 3: INCEST, REPEATER

The above-named defendant on or between Thursday, June 1, 2017, and Friday, September 1, 2017, in the Village of Hobart, Brown County, Wisconsin, did have sexual intercourse with a child he knows is related by blood or adoption, to a degree of kinship closer than second cousin, AGS, an eight-year- old child, contrary to sec. 948.06(1), 939.62(1)(c) Wis. Stats., a Class C Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

And further, invoking the provisions of sec. 939.62(1)(c) Wis. Stats., because the defendant is a repeater, having been convicted of Possession of THC in Brown County Case Number 18CM1184 on or about August 20, 2019 and Possess Drug Paraphernalia and Bail Jumping in Shawano County Case Number 18CM457 on or about July 30, 2019, which conviction(s) remain of record and unreversed, the maximum term of imprisonment for the underlying crime may be increased 2 years if the prior convictions were for misdemeanors.

Count 4: CHILD ENTICEMENT, REPEATER

The above-named defendant on or between Thursday, June 1, 2017, and Friday, September 1, 2017, in the Village of Hobart, Brown County, Wisconsin, with intent to have sexual intercourse with the child in violation of Section 948.02, Wis. Stats., did cause a child, AGS, a n eight-year- old child, who had not attained the age of 18 years to go into a room, contrary to sec. 948.07(1), 939.62(1)(c) Wis. Stats., a Class D Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than twenty five (25) years, or both.

And further, invoking the provisions of sec. 939.62(1)(c) Wis. Stats., because the defendant is a repeater, having been convicted of Possession of THC in Brown County Case Number 18CM1184 on or about August 20, 2019 and Possess Drug Paraphernalia and Bail Jumping in Shawano County Case Number 18CM457 on or about July 30, 2019, which conviction(s)

remain of record and unreversed, the maximum term of imprisonment for the underlying crime may be increased 2 years if the prior convictions were for misdemeanors.

Count 5: FALSE IMPRISONMENT, REPEATER

The above-named defendant on or between Thursday, June 1, 2017, and Friday, September 1, 2017, in the Village of Hobart, Brown County, Wisconsin, did intentionally confine AGS, without that person's consent, and with the knowledge that he had no lawful authority to do so, contrary to sec. 940.30, 939.62(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

And further, invoking the provisions of sec. 939.62(1)(b) Wis. Stats., because the defendant is a repeater, having been convicted of Possession of THC in Brown County Case Number 18CM1184 on or about August 20, 2019 and Possess Drug Paraphernalia and Bail Jumping in Shawano County Case Number 18CM457 on or about July 30, 2019, which conviction(s) remain of record and unreversed, the maximum term of imprisonment for the underlying crime may be increased 2 years if the prior convictions were for misdemeanors.

Complainant is a Special Prosecutor with the Brown County District Attorney's Office and knows of the above offense(s) on information and belief based upon:

PROBABLE CAUSE:

The complainant, being duly sworn on oath, swears that she has had the opportunity to review the police reports from Officer Dustin Muenster of the Oneida Police Department, and other documents supporting this complaint referenced herein, which are the types of reports and documents kept in the ordinary course of business, which complainant believes to be truthful and reliable because they have proven to be truthful and reliable on numerous occasions in the past.

The complainant further asserts that based upon her review of the referenced reports and/or supporting documents, the incidents alleged occurred in the Village of Hobart, Brown County, Wisconsin.

1. Your complainant's review of the reports of Officer Dustin Muenster of the Oneida Police Department, which state:

On Tuesday, February 02, 2021 at approximately 4:07PM, I, Officer Dustin Muenster was dispatched to the Oneida Police Department on 2783 Freedom Road, in the Village of Hobart, Brown County for a sex offense. Dispatch advised the reporting parties, G.E.S.'s daughter, A.G.S., an eleven year old female, was sexually assaulted when she was eight years old. Dispatch advised to meet G.E.S. in the Department Lobby.

Upon arrival, I met with G.E.S., A.G.S., and A.G.S.'s mother, A.M.S. A.G.S. was visibly distraught and crying. I asked A.G.S. if she could explain to me what happened. A.G.S. wouldn't talk initially but eventually said, "He touched me, in the wrong places." I asked A.G.S.

who "he" was, and she said, "Uncle Jared." Later identified by G.E.S. as Jared L. Skenadore, DOB: 11/09/1997. I asked A.G.S. when this happened, and she stated during summer break when she was eight. I asked A.G.S. where she was touched. A.G.S. made a gesture with her hand towards her groin area. I asked A.G.S. what Uncle had touched her with and she, "His private parts." A.G.S. started crying and became inconsolable. I asked A.M.S. if she would take A.G.S. to their vehicle and I would continue to talk with G.E.S. I asked G.E.S. where the incident occurred. G.E.S. stated A.G.S. staved at her Grandparent's house that summer and that's where Jared would babysit the kids. G.E.S. said the Grandparent's lived on Merrimac Way in the Village of Hobart, Brown County, G.E.S. stated he was speaking with A.G.S. about A.M.S.'s boyfriend and about how G.E.S. thought he was a registered sex offender. G.E.S. stated A.G.S. asked what a sex offender was. G.E.S. explained to A.G.S. what a sex offender was. Later in the day A.M.S. dropped A.G.S. off and she was crying. G.E.S. said he asked A.G.S. why she was crying and A.G.S. said it was because she was thinking about what he said about sex offenders and it gave her flashbacks of what Uncle did to her. He asked what Uncle did to her and A.G.S. said, "He raped me." G.E.S. said he asked A.G.S. what she meant by that and A.G.S. made a circle with her fingers on one hand and put the index finger from the other hand through the circle. G.E.S. said they waited until the day after to bring her into the police department to file a report. I gave G.E.S. two copies of the Victim's Rights Information Sheet, one for each parent, and I told him I would get back to him at a later time to set up an appointment for a forensic interview at the Willow Tree Child Advocacy Center.

On Wednesday, February 17, 2020 at approximately 11:18AM, Forensic Interviewer Megan Hackl of the Willow Tree Child Advocacy Center (CAC), in the City of Green Bay, Brown County, conducted a recorded forensic interview with A.G.S. At the beginning of the interview, Megan explained to A.G.S. not to guess at an answer for any of the guestions she is asked. Megan advised A.G.S. that it was okay for her to say, "I don't know." Megan also explained to A.G.S. that if she were to make a mistake with something A.G.S. said, A.G.S. was supposed to correct her. A.G.S. said she understood. Megan also explained to A.G.S. they were only going to talk about things that were true. Megan asked A.G.S. to explain the difference between something that was the truth and something that was a lie. A.G.S. stated, "Telling the truth is like you're telling what actually happened." Megan asked A.G.S. what a lie was. A.G.S. said, "To tell someone something that's not true." Megan asked A.G.S. to go through some examples of telling the truth and telling a lie. Megan gave an example of a kid at school who took a book off the teacher's desk. The teacher asks the kid, "Did you just take that book off my desk?" and the kid replied, "No, I didn't take a book." Megan asked A.G.S. if what the kid said was a truth or a lie. A.G.S. said, "A lie." Megan said the kid goes home from school and takes a cookie out of the cookie jar and then mom asks, "Did you just take a cookie out of the jar?' and the kid says, "Yes I did." Megan asked A.G.S. if what the kid said was the truth or a lie. A.G.S. stated, "Truth." Megan asked A.G.S. if it was important to tell the truth and A.G.S. said, "Yeah." Megan asked A.G.S. what would happen if a kid or an adult would lie. A.G.S. said, "They'd get in trouble." Megan asked A.G.S. if she would promise to tell the truth and A.G.S. said, "Yeah." Megan asked A.G.S. if she knew what brought her there to the CAC. A.G.S. said, "I been through stuff when I was eight." Megan asked A.G.S. if she could start from the beginning and to tell her everything she remembered.

A.G.S. said at the beginning of summer break when she was eight years old (2017), her parents dropped her off at her Grandma and Grandpa's house while they went to work. A.G.S. said when she first got there, they would play games for a little bit before, "Uncle asked me to

go to the room with him." Megan asked A.G.S. to tell her more about when Uncle would ask her to go to the room. A.G.S. said, "He would make me take off my clothes." A.G.S. also said, "Most of the days, he would make me suck his private part when I didn't want to." A.G.S. said, "Some days he would just put his private part in me." A.G.S. said, "He would force me." A.G.S. began to cry and said, "That's why I asked Grandma everyday if she had no work because I wanted to stay with her." A.G.S. said, "He's been doing that until the end of summer break." A.G.S. stated, "Then I would just hide it because I was too scared to tell anyone." Megan thanked A.G.S. for sharing with her. Megan asked A.G.S. to go back and make sure she got everything right. Megan asked A.G.S. if she heard this happened during summer break when she was eight years old. Megan asked, "Is that right or wrong?" A.G.S. said, "Right."

Megan asked A.G.S. if she could talk more about going over to Grandma and Grandpa's house. A.G.S. said she would, "be excited" in the morning but when she got there, she would remember what would happen. A.G.S. said she would try to ignore Uncle but then he would, "Be mean to me and yell at me." A.G.S. stated that Uncle would yell at her to go in the room or he would "Do bad things to me." A.G.S. stated she didn't know what that meant so "I went in the room because I was scared." A.G.S. said that summer her Grandpa would leave early for work and Grandma would leave shortly after A.G.S. would get there. A.G.S. said it was usually just her Uncle Jared, her two brothers, and her cousin at the house together. A.G.S. stated she thought the room at the house her Uncle told her to go into was her Aunt's. When Megan asked A.G.S. to describe the room, A.G.S. stated the bed was in the middle of the room and she thought the bed was grey. A.G.S. said that was all she remembered because she, "Tried to forget it."

A.G.S. stated the first thing her Uncle would do when she went inside the room was "Lock the door." A.G.S. said after Uncle locked the door, he would tell A.G.S. to take off her clothes or he would take off his pants. A.G.S. said Uncle would tell her to take off her clothes because on certain days he would, "Put his private part in me." A.G.S. said on the days he just took his pants off he would, "Make me suck his private part." When Megan asked A.G.S. to tell her about when Uncle would take off his pants A.G.S. stated she would just, "Look away because I didn't want to do it." A.G.S. said after he took off his pants he would, "Make me come over there." Megan asked A.G.S. where Uncle would be in the room when he told her to come over by him and A.G.S. stated, "By the bed." A.G.S. said after she would go over by him, he would, "Make me suck his private part." When Megan asked A.G.S. to tell her about Uncle's private part, A.G.S. shook her head "no," and didn't want to answer. Megan asked A.G.S. what Uncle's private part felt like when he made her suck it. A.G.S. shook her head again and began to cry. Megan asked A.G.S. how she was feeling at that moment and A.G.S. said, "Sad." Megan asked A.G.S. to tell her about feeling sad. A.G.S. continued to cry but said, "I just don't like thinking about the past." A.G.S. then stated, "But I would have nightmares of it." A.G.S. continued to cry and Megan asked A.G.S. if she wanted to take a break. A.G.S. nodded her head and said, "Yes."

Megan asked A.G.S. if she wanted to talk about something else and A.G.S. said, "Yeah." Megan and A.G.S. began talking about Grandma and Grandpa's house. A.G.S. described the house as "Yellow" with a "Big backyard." A.G.S. described where the garage was and a bush in the backyard. A.G.S. also described where the dining room, living room, and bedrooms were. Megan asked A.G.S. how often she went over to Grandma and Grandpa's house. A.G.S. stated she would go there usually Monday through Friday or sometimes on the weekends.

A.G.S. said if her parents didn't have to work, she would stay with them instead. When Megan asked A.G.S. how she remembered this was the summer when she was eight, A.G.S. said she remembered being in 2nd and 3rd grade (2017/2018). Megan asked A.G.S. what her parents did for work during that summer. A.G.S. stated her dad has the same job in construction and she thought her mom did cleaning.

Megan began asking A.G.S. about the room again. Megan asked if A.G.S. knew what Aunt the room belonged to. A.G.S. said, "Auntie Andrea." Megan asked where A.G.S.'s brother and cousin were in the house usually when they went over to Grandma and Grandpa's. A.G.S. said they would be playing games in the living room. A.G.S. asked where Grandma would be and A.G.S. said she would be in her room until she had to leave for work. Megan asked A.G.S. who would be in charge after Grandma left. A.G.S. said, "Uncle." Megan asked A.G.S. more about when she was in the room with Uncle. Megan asked what Uncle's body would be doing when she had to suck on his private. A.G.S. stated he would, "Push my head more in." When Megan asked A.G.S. how Uncle would push on her head, A.G.S. made a motion with her righthand palm out fingertips' up, pushing her hand forward. A.G.S. said, "Like that." Megan asked A.G.S. how Uncle would have her positioned when he would make her suck on his private part. A.G.S. said, "Sitting down." Megan asked how Uncle's private part felt when he made her suck on it. A.G.S. said, "I don't know." Megan asked A.G.S. what she tasted when she had to suck on Uncle's private part. A.G.S. said, "I don't remember." Megan asked A.G.S. how sucking on Uncle's private part would stop. A.G.S. said she would suck on his private part for a "couple minutes" before he would tell me to stop. A.G.S. said then they would leave the room and he would, "Let me be for the rest of the day." Megan asked A.G.S. if Uncle would say anything before they would leave the room. A.G.S. said Uncle would, "Tell me not to tell anvone." A.G.S. said he would say it "all mean" and would tell her if she told anvone that. "Bad things were going to happen." Megan asked A.G.S. how she would feel after Uncle would say those things to her. A.G.S. said she, "Felt scared." Megan asked A.G.S. about feeling scared. A.G.S. said she, "Felt scared because it just didn't feel right."

Megan asked A.G.S. what Uncle's private part looked like. A.G.S. had an approximate 15 second pause before she answered, "What a boy's private part would look like." Megan asked A.G.S. what that looks like to her. A.G.S. had an approximate 26 second pause before she answered, "Like hotdogs." Megan asked A.G.S. about a time where her clothes would be off and how they would come off. A.G.S. said, "Sometimes he would take off my clothes and sometimes I would have to."

Megan asked A.G.S. what clothes Uncle would take off. A.G.S. said, "He would take off my pants, and sometimes my underwear." Megan asked A.G.S. where in the room she would be when Uncle would take off her pants and underwear. A.G.S. stated, "By the bed." Megan asked what would happen next after he would take off her pants and underwear. A.G.S. stated, "He would put his private part in me." Megan asked A.G.S. where Uncle's clothes would be on his body. A.G.S. said, "He would only take off his pants and underwear as well." Megan asked A.G.S. to tell her about when Uncle would put his private part in her. A.G.S. stated, "He put it in my butt." Megan asked A.G.S. where his body would be when he put his private in her butt. A.G.S. said, "Behind me." Megan asked A.G.S. what Uncle's hands and arms would be doing when he was behind her. A.G.S. said, "Holding me." Megan asked A.G.S. to explain how he would hold her. A.G.S. stated that he would hold her from her waist. Megan asked A.G.S. what his head would be doing. A.G.S. said, "Looking down." Megan

asked A.G.S. what Uncle's body would be doing when his private was in her butt. A.G.S. said, "Moving." Megan asked A.G.S. how Uncle's body would be moving. A.G.S. held up her hand fingertips pointing out palm facing in and made a gesture moving her hand left to right and back saying, "Like that." Megan asked A.G.S. if she saw her hand moving back and forth and A.G.S. said, "Yeah." Megan asked A.G.S. if she felt anything else when his private was in her butt. A.G.S. said, "His hands." Megan asked A.G.S. what would happen next. A.G.S. said that Uncle would tell her to put her clothes back on. Megan asked A.G.S. if she ever felt anything on her body or asked if there was ever any cleanup that had to be done. A.G.S. said she, "Constantly had to use the bathroom a lot." Megan asked A.G.S. to tell her about having to use the bathroom a lot. A.G.S. stated, "It would hurt to go to the bathroom sometimes." A.G.S. also said that, "It would sting every time I went pee." Megan asked A.G.S. if she would ever feel anything when she had to poop. A.G.S. said, "It would hurt sometimes." Megan asked A.G.S. if she ever feel anything when she had to poop. A.G.S. said, "It would hurt sometimes." Megan asked A.G.S. if she ever feel anything in her pee or poop that wasn't supposed to be there. A.G.S. said, "No." Megan asked A.G.S. if it hurt to do anything else besides peeing or pooping and A.G.S. said that she didn't think so.

Megan asked A.G.S. to tell her about how Uncle would only take off her underwear sometimes. A.G.S. said, "He only took off my underwear once a week or sometimes two times a week." A.G.S. also said, "The rest he would just make me suck his private part." Megan asked A.G.S. if there was ever a time where his private part touched somewhere on her body other than her mouth or in her butt. A.G.S. said, "Just my mouth." Megan asked A.G.S. if he ever had her touch anywhere else on his body. A.G.S. said, "No." Megan asked A.G.S. if Uncle every did any touching with his mouth on her body. A.G.S. shook her to say no.

Megan asked A.G.S. how often the touching would happen while she was at her Grandma's. A.G.S. said, "Half of the week." Megan asked A.G.S. to help her understand that more. A.G.S. said, "Some days he would just leave me alone but then if not, he would do that stuff to me." Megan asked A.G.S. if that stuff would happen every week or if there were some weeks where the touching didn't happen. A.G.S. said, "I think it would happen every week." Megan asked A.G.S. to tell her about how it stopped when summer break ended. A.G.S. stated, "I felt happy that I didn't have to go through that again." Megan asked A.G.S. to tell her more about being scared to tell anyone. A.G.S. said, "I just hid it from everybody." Megan asked A.G.S. how it made her feel that she had to hide it from everyone. A.G.S. stated, "It put pressure on me." Megan asked A.G.S. to tell her more about feeling pressure. A.G.S. said, "It was like I was holding up a building." Megan asked A.G.S. who did know about what happened with her Uncle. A.G.S. said, "My mom, my dad, my grandma, my other grandma, and my Auntie." Megan asked A.G.S. who she told. A.G.S. said, "Grandma and my mom and dad." Megan asked A.G.S. what was going on that she decided to tell when she did. A.G.S. said, "My dad told me about my mom's boyfriend and what he went to jail for." A.G.S. continued to say, "it gave me memories of what happened. A.G.S. said, "I was fine before but a lotta more memories came up and I started crying and it just fell out of my mouth."

Megan asked where Uncle Jared would be living when he was babysitting her. A.G.S. said he would either be staying at her Uncle Jason's house or at her Grandma's. Megan asked A.G.S. after the summer break ended, if she still saw her Uncle after that. A.G.S. said, "Yeah." Megan asked A.G.S. how it was seeing him. A.G.S. said, "He stopped touching me." Megan asked A.G.S. if she still sees her Uncle. A.G.S. said, "Not anymore." Megan asked A.G.S. to tell her about not seeing him anymore. A.G.S. stated, "Once I told my dad he said I couldn't go to

Grandpa and Grandma's no more because he didn't want me over there again." Megan asked A.G.S. if that was where Uncle still lived was at Grandma and Grandpa's house. A.G.S. confirmed that's where he still lived. Megan asked A.G.S. to confirm her Uncle's name who they had been talking about. A.G.S. said, "Uncle Jared." Megan asked A.G.S. what Uncle Jared's last name was. A.G.S. said, "Skenadore but with one N." Megan asked A.G.S. if she knew of Uncle Jared doing these things with somebody else. A.G.S. shook her head no. Megan asked A.G.S. if something like this happened to her but with somebody else. A.G.S. shook her head no. Megan told A.G.S. they would take a break from the interview. Megan asked A.G.S. to think if there was anything she wanted to talk to her about after the break before Megan left the room.

When Megan returned, she asked A.G.S. if she had thought of anything she wanted to talk to her about.

Megan asked A.G.S. to tell her more about having nightmares because of what happened with Uncle Jared. A.G.S. said, "Sometimes I would think about it and I would try to forget it, when I go to bed it would just pop up images of what used to happen. Megan asked A.G.S. how else what happened with Uncle Jared affected her aside from the nightmares. A.G.S. said she didn't know. Megan asked A.G.S. if she thought about what happened with Uncle Jared any other time besides right before bed. A.G.S. said, "No, I just think about it when I go to bed." Megan asked A.G.S. when the nightmares first started. A.G.S. said around the time she started virtual school. Megan asked A.G.S. if anything happened and that the memories would just "Pop up."

Megan asked about when Grandma would leave for work. Megan asked what Grandma would say when A.G.S. would ask her to stay home from work. A.G.S. said that her Grandma would say no. A.G.S. said, "I would just sit on her bed until she left." Megan asked A.G.S. if Uncle Jared ever brought her into any other rooms. A.G.S. said she didn't think so. Megan asked A.G.S. if she ever saw Uncle Jared bring anyone else into the room. A.G.S. said she didn't know. Megan asked A.G.S. if she had another name for Uncle Jared's private part just to help her understand better what A.G.S. was referring to. A.G.S. said, "No." Megan asked A.G.S. what his private part helps him do or what is there for. A.G.S. said, "For putting it in me." A.G.S. also said that she didn't know else it was for. Megan presented to A.G.S. a piece of paper with an outline of a male body on it. Megan explained to A.G.S. there was the front side of a boy and the back side of a boy and she asked A.G.S. to draw and X over the area of the boy where his private part is located. A.G.S. made a mark on the front side outline of the male body over the area of where the groin is located. Megan asked A.G.S. if she ever saw Uncle Jared put anything on his private part before he put it in her butt. A.G.S. said, "No." Megan asked A.G.S. if she ever felt or saw anything come out of Uncle Jared's private part. A.G.S. said, "I don't know." Megan asked A.G.S. if she ever observed anything about Uncle Jared's private part other than that it looked like hotdogs. A.G.S. said, "I don't know." The forensic interview with A.G.S. ended at approximately 12:20PM.

On February 18, 2021 at approximately 4:20PM, A.M.S. came to the Oneida Police Department to give a written statement regarding when her daughter disclosed the sexual abuse. A.M.S. stated on February 1, 2021 at around 6PM she dropped A.G.S. of at A.G.S.'s dad's house. A.M.S. said that A.G.S. was crying on the drive there but wouldn't tell her why.

A.M.S. said she dropped A.G.S. off with her dad and left. A.M.S. said G.E.S. called her and told her to come back. A.M.S. said when she got there, G.E.S. and A.G.S. came outside. A.M.S. stated A.G.S. said she was too afraid to tell her that her uncle "Raped her." A.M.S. said she asked what Jared did to her and A.G.S. made a circle with her fingers on one hand and took her index finger from her other hand and put it through the circle on her other hand. A.G.S. told her it was her Uncle Jared. A.M.S. said A.G.S. didn't give any more details and continued to cry. The next day, they went into the Oneida Police Department to file a report.

On February 25, 2021 at approximately 9AM, SGT Nate Ness went to Jared's residence of N6920 Cornelius Circle in the Town of Oneida, Outagamie County, to make contact with Jared. SGT Ness took Jared into custody, placed him under arrest, and transported him to the Brown County Jail for charges of: 948.02(1)(b) First Degree Sexual Assault of a Child: Sexual Intercourse with a Person who has not Attained the Age of 12 Years, 948.02(1)(d) First Degree Sexual Assault of a Child: Sexual Contact with a Person who has not Attained the Age of 12 Years, 948.02(1)(d) First Degree Sexual Assault of a Child: Sexual Contact with a Person who has not Attained the Age of 16 Years by Use or Threat of Force or Violence by a Person who has Attained the Age of 18 Years, 948.025 Repeated Acts of Sexual Assault of a Child, 940.30 False Imprisonment, and 948.06(1) Incest with a Child: Sexual Intercourse or Sexual Contact.

On February 25, 2021 at approximately 3:18PM G.E.S. came to the Oneida Police Department to give a written statement. G.E.S. stated on February 01, 2021 at approximately 7PM, A.M.S. dropped A.G.S. of at his residence. G.E.S. stated A.M.S. told him A.G.S. had been crying before getting dropped off, but she would not tell A.M.S. why. G.E.S. said A.M.S. left and he was eventually able to calm A.G.S. down enough to get her to talk about what was going on. G.E.S. said A.G.S. asked him if he remembered the conversation they had previously about A.G.S.'s mom's boyfriend and sex offenders. G.E.S. told her that he remembered. G.E.S. stated A.G.S. told him it gave her flashbacks about what uncle used to do to her. G.E.S. said he asked A.G.S. which Uncle and A.G.S. said, "Jared." G.E.S. said A.G.S. started crying again. G.E.S. said he got her calmed down enough to talk again and he asked what Uncle Jared did to her. G.E.S. said A.G.S. told him that Uncle Jared "Raped me." G.E.S. said he asked A.G.S. what he did and A.G.S. made a circle with her fingers on one hand and stuck her pointer finger from her other hand through the circle. G.E.S. said A.G.S. continued to cry. G.E.S. said he called A.M.S. and told her to come back. G.E.S. said when A.M.S. got there he told A.G.S. to tell A.M.S. what she had told him. G.E.S. stated that A.G.S. said, "Uncle raped me." G.E.S. said he asked A.G.S. what Uncle did, and she made the same finger gesture as before. G.E.S. said A.M.S. seemed mad at A.G.S. because she said, "You better not be fucking lying." G.E.S. said he told A.M.S. to calm down and they decided to wait until the following day to report the abuse.

I asked G.E.S. what school A.G.S. attended at the time of the abuse. G.E.S. stated A.G.S. was going to Hillcrest Elementary School, in the Village of Hobart, Brown County. I asked G.E.S. when the summer break began and ended for Hillcrest Elementary. G.E.S. stated the school year ended at the end of May and would start back up in early September.

2. Your complainant's review of the records of the Wisconsin Circuit Court Access Program (CCAP) website, which records are presumed truthful and reliable as they are kept in the normal and ordinary course of departmental business. These records indicate that Jared Lee Skenadore, DOB: 11/09/1997, the defendant, was the defendant in Brown County Case Number 18CM1184. Said records indicate that on or about August 20, 2019, there was a

disposition in said case with a Judgment of Conviction on a charge of Possession of THC, a misdemeanor contrary to sec. 961.41(3g)(e) Wis. Stats. Your complainant's further review of the CCAP website indicates that the defendant was the defendant in Shawano County Case Number 18CM457. Said records of that case indicate that on or about July 30, 2019, there was a disposition with a Judgment of Conviction on charges of Possess Drug Paraphernalia and Bail Jumping, misdemeanors, contrary to sec. 961.573(1) and 946.49(1)(a), respectively. Said conviction(s) remain of record and unreversed, making the defendant a repeater.

Based on the foregoing, the complainant believes this complaint to be true and correct.
