ORDER GRANTING PLAINTIFFS' VERIFIED SECOND MOTION FOR POSSESSION AND INJUNCTIVE RELIEF

This matter having come before this Court on the Verified Second Motion for Possession and Injunctive Relief filed by Plaintiffs Prime Alliance Bank, Inc. ("PAB") and Sertant Capital, LLC ("Sertant") (collectively, "Plaintiffs"); this Court conducted a hearing on November 20, 2023; Joseph Grekin appeared for Plaintiffs and no one appeared for Defendants; and for the reasons more fully stated on the record

NOW, THEREFORE, THIS COURT HEREBY FINDS THAT:

A. On October 13, 2022, Sertant Capital, LLC ("Sertant") and The Great Lakes Tissue Company ("GLT") entered into a Master Lease Agreement ("Master Lease") and a Lease Schedule No. 1 (collectively, "Lease"), under which Sertant leased the Equipment attached on Exhibit 1 to this Order (collectively, the "Equipment") to GLT;

- B. Sertant assigned certain rent payments and residual interest rights under the Lease and the Equipment to Prime Alliance Bank, Inc. ("PAB") (PAB and Sertant shall collectively be referred to as "Plaintiffs");
- C. The Equipment is located at 437 S. Main Street, Cheboygan, Michigan ("Paper Mill");
- D. GLT materially breached and committed Events of Default under the Lease by:
 - (a) failing to pay rent due under the Lease on January 1, 2023, and February 1, 2023;
 - (b) changing ownership, control and/or management of GLT without Plaintiffs' prior written consent, resulting in a material deterioration of GLT's creditworthiness as determined by Plaintiffs in their sole discretion;
 - (c) falsely representing ownership or possession of and/or selling, scrapping, or disposing of 21 pieces of Equipment without Plaintiffs' knowledge, authorization, or consent;
 - (d) transferring possession and/or control of the Equipment to Tissue Depot, Inc. ("Tissue Depot") without Plaintiffs' prior consent;
 - (e) fraudulently transferring its assets to Tissue Depot with the intent to hinder delay, and defraud creditors, including Plaintiffs, and/or for less than reasonably equivalent value when GLT was insolvent or rendered insolvent;
 - (f) ceasing business operations by transferring its assets, including the Equipment, to Tissue Depot; and
 - (g) becoming insolvent and unable to pay its debts in the ordinary course of business before and after transferring its assets to Tissue Depot and/or Cheboygan Entergies & Biofuels Corp. ("CEB").
- E. The Equipment will be damaged, destroyed, concealed, disposed of, or used so as to substantially impair its value before final judgment unless taken into custody by court order because: (1) GLT fraudulently

transferred its assets, including the Equipment, to Tissue Depot, to hinder, delay, and defraud creditors upon discovery of this lawsuit, (2) Tissue Depot abandoned the Equipment at the Paper Mill; (3) the Paper Mill has no electricity, gas, or operable fire suppressions system; (4) the sump pump in the basement of the Paper Mill is inoperable, causing the basement to flood with water exposing the Equipment to damage; (5) Tissue Depot laid off its employees; (6) the landlord for the Paper Mill has or will commence eviction proceedings; (7) the Equipment is exposed to potential theft or damage because the exterior wall to the Paper Mill is made of plywood, and (8) Tissue Depot and GLT has ceased operations;

- F. As a result of the Events of Default, material breaches of the Lease, and the immediate harm to the Equipment as described above, Plaintiffs have a right to possession of the Equipment;
- G. Plaintiffs are not required to post a bond because they own the Equipment and have a right to possession;
- H. GLT owned certain intellectual property and/or environmental permits ("Environmental Permits") that allowed it to use or discharge water. After learning of this case, GLT fraudulently transferred the Environmental Permits to Tissue Depot with the intent to hinder delay, and defraud creditors, including Plaintiffs, and/or for less than reasonably equivalent value when GLT was insolvent or rendered insolvent;
- I. The Environmental Permits are purportedly worth \$21 million and represent GLT and/or Tissue Depot's most valuable asset;
- J. GLT and Tissue Depot ceased operations and laid off its employees. Given GLT's prior fraudulent transfer of its assets to Tissue Depot, Plaintiffs justifiably are concerned that the Environmental Permits will be transferred so as to render Tissue Depot, GLT, and/or CEB (collectively, "Defendants") uncollectible;
- K. Plaintiffs are substantially likely to prevail on their claims for the reasons set forth in Section (D) above;

- L. Entry of an injunction prohibiting the transfer of the Environmental Permits serves the public interest;
- M. Defendants are insolvent, and/or there is a strong possibility that the Plaintiffs would not receive adequate compensatory relief in the absence of an injunction; and
- N. Plaintiffs will suffer irreparable harm without the granting of injunctive relief;

IT IS HEREBY ORDERED that Plaintiffs are awarded immediate possession of the Equipment. This Court's prior injunction entered in on April 12, 2023, shall remain in full force and effect. (ECF No. 24.) The sheriff or court officer is hereby directed to seize the Equipment within 21 days and either hold it or deliver it to Plaintiffs. Plaintiffs shall not be required to furnish a penalty bond.

IT IS HEREBY FURTHER ORDERED THAT The Great Lakes Tissue Company, Tissue Depot, and Cheboygan Energies & Biofuel Corporation, and their agents, representatives, attorneys, shareholders, members, directors, officers, employees, and all other persons acting in concert with any of them, are enjoined from selling, transferring, canceling, conveying, encumbering, hypothecating, or otherwise disposing of the Environmental Permits without this Court's authorization.

IT IS HEREBY FURTHER ORDERED THAT, within five days from the date of this Order, The Great Lakes Tissue Company, Tissue Depot, and Cheboygan Energies & Biofuel Corporation escrow the Environmental Permits with M.S. Title Agency in Southfield, Michigan ("M.S. Title"), and certify under penalty of perjury

that who owns them and that the Environmental Permits have not been transferred

or sold within the past (90) days. Plaintiffs shall pay M.S. Title's fees for escrowing

the Environmental Permits. M.S. Title shall release the Environmental Permits only

upon further order of this Court, and shall incur no liability to any party for holding

the Environmental Permits in escrow.
