Comments:

In Brown County Case 19CF0897, 23CF1055, Desmond Jordan was court ordered to report to and comply with Criminal Justice Services. On 11/10/23 Desmond Jordan reported in for his random drug screen. Desmond Jordan's sample came back invalid on the instant oral test. Writer then had Desmond Jordan complete a lab test and sent it out to Redwood Toxicology for results. Writer received preliminary results from Redwood Laboratory on 11/15/23 that indicated Desmond Jordan's sample tested positive for alcohol, THC, and cocaine. Writer requested Desmond Jordan's sample be retested to confirm these results. On 12/19/23, Writer received confirmation results from Redwood Toxicology. Results confirmed that Desmond Jordan had



alcohol (Ethanol) GC-FID Confirmation (0.124 g/dL) Benzoylecgonine (8 ng/mL) Cocaine (44 ng/mL) Delta-9-THC (562 ng/mL) in his system. Writer will discuss these results with Jordan Desmond when he comes in for his next random drug screen. Jordan Desmond is scheduled for a court appearance on 03/19/24 at 8:45am in Branch 7.
