CRIMINAL COMPLAINT

For Official Use

Complainant, an Assistant District Attorney, being first duly sworn on oath, deposes and says that:

Count 1: HIT AND RUN - ATTENDED VEHICLE

The above-named defendant on or about Friday, January 25, 2019, in the City of Green Bay, Brown County, Wisconsin, did operate a vehicle involved in an accident that resulted in damage to a vehicle which is driven or attended by any person and failed to reasonably investigate what was struck and if the operator knew or had reason to know that the accident resulted in injury or death of a person or in damage to a vehicle that is driven or attended by a person, and failed to stop the vehicle he was operating as close to the scene of the accident as possible and remain at the scene of the accident until he did the all of the following: give his name, address and the registration number of the vehicle he was operating to the operator or occupant of or person attending any vehicle collided with and, upon request and if available, exhibit his operator's license to the operator or occupant of or person attending any vehicle collided with, contrary to sec. 346.67(1), 346.74(5)(a) Wis. Stats., a Misdemeanor, and upon conviction shall be fined not less than Three Hundred Dollars (\$300) nor more than One Thousand Dollars (\$1,000), or imprisoned for not more than six (6) months, or both.

Complainant is an Assistant District Attorney with the Brown County District Attorney's Office and knows of the above offense(s) based upon:

1. Complainant's review of the reports of Officer Bahl of the Green Bay Police Department, who indicates that on January 25, 2019, at approximately 7:52 P.M. in the City of Green Bay, Brown County, Wisconsin:

I was working for the Green Bay Police Department in full uniform and in a fully marked squad as unit 3a1. At 1952 hours, I was dispatched to a hit and run accident in the area of W Mason St and Hinkle St. According to the complainant, who I later identified by WI/DL as Cody A Gille

M/W, the run vehicle had a license of BC1018 and was on a gray Town and Country. According to DOT the license plate comes back on a 2006 Town and Country registered to Jacqueline R Thomas F/I, who resides at 2250 S Overland Dr. Moments later I was dispatched to the call. While en route dispatch stated the complainant called back and stated the run vehicle was behind a snow bank at Scoreboards Bar and Grill. A short time later I arrived at Scoreboards and located the run vehicle (Tribal plate: BC1018). The vehicle was parked in the rear of the parking lot facing E/B in the snow. When I walked out of my squad I located front end damage to the vehicle. No one was located inside the vehicle and after walking around the vehicle I noticed there were no shoe prints in the snow other than one set leaving from the front driver door. Due to the other tire impressions on the snow I could not determine if the person entered the bar, and based on the registered owners information I did not go inside Scoreboards as I believed someone else was driving the vehicle.

I later arrived at Grand Central (2597 W Mason St) and met with the complainant, Cody, and observed the hit vehicle: Packer plate 21090G registered on a 2005 Toyota Tundra. I made contact with the driver, later verbally identified as Karstin J Vanstechelman M/W. Karstin told me he was traveling N/B on Packerland Dr and was going to pull into Grand Central Station. He explained the vehicle came off one of the roads by Southwest High (possibly Trojan Dr) and later rear ended him. I walked over to the rear end of the vehicle with him and observed minor damage to the rear end, which matched the damage to the run vehicle. I later obtained a statement from Karstin. He stated he was traveling N/B on Packerland Dr in the outside lane of traffic near Southwest High when he was rear ended. He obtained a license plate BC1018, which he stated was a gray Town and Country and left the area E/B on W Mason St frontage Rd without leaving any information. Karstin did not see who was driving. I later reviewed the statement with Karstin and he agreed everything was true and accurate and signed the statement. While at Grand Central Station I called dispatch and asked them to send another officer/deputy to Jacqueline 's address and have her call me. I then received a phone call from Jacqueline. She told me she was not driving her vehicle, and gave her nephew 's information: Jolee Michael Skenandore M/I (01/29/1975). She explained Jolee was driving her vehicle and they (his family) were looking for him. Jacqueline told me Jolee lives at her residence. I explained to her what happened and gave her my phone number. I asked for her to call me back if and when she hears from Jolee.

After I obtained a physical description of Jolee from Jacqueline, I started to drive back towards Scoreboards. After pulling out of Grand Central Station and traveling E/B on W Mason St frontage Rd I noticed a M/I walking W/B on W Mason St frontage Rd in the middle of the road matching the description Jacqueline gave me of Jolee. I also believed it was Jolee due to the temperate outside, approximately -4 degrees outside, and there not being a lot of pedestrian traffic at this time. The male also appeared to be stumbling and was having difficulty walking/keeping his balance. I later made contact with the male, who I later identified by Arizona/ID as Jolee. Jolee appeared to be highly intoxicated, but still able to walk, talk, and know what was going on. I explained to him why I was making contact with him (hit and run accident, and me getting off the phone with Jacqueline and her telling me he was driving her vehicle). Jolee told me he was not driving and was walking: although he had keys to the vehicle in his hand. He also told me he was not driving that his friend was driving. He told me he was walking from Scoreboards and was drinking there. I eventually asked him who was driving if he was not. He told me his friend was. I asked what his friend 's name was so I could talk to him, as I was going to issue him/her a citation and if I could not locate his friend I was going to issue a citation to Jacqueline for hit and run owner 's liability. Jolee then told me the friend who was driving the vehicle name was Jolee Skenandore. I told Jolee so the driver of

the vehicle was him. Jolee then started to walk away from me and I placed my right hand on his left arm and told him he was being detained and hand cuffed him, patted him down, and placed him in the back seat of my squad. I then called Jacqueline and placed her on speaker phone. I updated her on the incident and explained I was out with Jolee. While on the phone with Jacqueline, Jolee stated fuck you multiple times. I explained I would be issuing Jolee the citation and explained her vehicle was at Scoreboards. I later ran Jolee and according to DOT his license was canceled. I later issued and explained to him two citations: hit and run, and operating without a license. I later unhandcuffed him after clarifying that he was not injured as a result of the accident.

Complainant states she believes the information received from Officer Bahl to be true and accurate in that he is a law enforcement officer who has provided true and accurate information in the past.
