CRIMINAL COMPLAINT

Complainant, Maggie R. Crawford, an Assistant District Attorney, being first duly sworn on oath, deposes and says that:

Count 1: FELONY BAIL JUMPING

The above-named defendant on or about Saturday, January 21, 2023, in the City of De Pere, Brown County, Wisconsin, having been charged with a felony in Brown County Case 2022CF97 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

Count 2: CRIMINAL TRESPASS

The above-named defendant on or about Saturday, January 21, 2023, in the City of De Pere, Brown County, Wisconsin, did intentionally enter the dwelling of KAV, without the consent of the owner of the property that includes the dwelling as no person was lawfully upon the premises, under circumstances tending to create a breach of the peace, contrary to sec. 943.14(2) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Count 3: DISORDERLY CONDUCT

The above-named defendant on or about Saturday, January 21, 2023, in the City of De Pere, Brown County, Wisconsin, while in a public or private place, did engage in abusive, boisterous, indecent, profane, unreasonably loud, violent or otherwise disorderly conduct, under circumstances in which such conduct tended to cause or provoke a disturbance, contrary to sec. 947.01(1) Wis. Stats., a Class B Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.

Complainant is an Assistant District Attorney with the Brown County District Attorney's Office and knows of the above offense(s) on information and belief based upon:

PROBABLE CAUSE:

The complainant, being duly sworn on oath, swears that she has had the opportunity to review the police reports from officers of the De Pere Police Department, and other documents supporting this complaint referenced herein, which are the types of reports and documents kept in the ordinary course of business, which complainant believes to be truthful and reliable because they have proven to be truthful and reliable on numerous occasions in the past.

The complainant further asserts that based upon her review of the referenced reports and/or supporting documents, the incidents alleged occurred in the City of De Pere, Brown County, Wisconsin.

1. Your complainant's review of the report prepared by Officer Townsend of the De Pere Police Department, which states in part:

On 01-21-2023 at approximately 08:46 AM I Officer Lee Townsend #411 and Officer Christian McCrander #454 were dispatched to the area of 8th Street and Oak Street in the City of De Pere for a report of a suspicious person prowling around houses, looking into windows, and possibly trespassing inside homes.

I arrived on scene with Ofc. McCrander. I observed Ofc. McCrander initiate his traffic lights and make a U-Turn behind a male matching the suspect description closely wearing a black hoodie and a baseball hat. The male appeared to be conspicuously ignoring Ofc. McCrander so I initiated my emergency lights on my marked squad car and exited the vehicle and introduced myself to the male and began walking toward him in full uniform. The male conspicuously ignored me and continued walking. I ordered the male to stop and he eventually stopped. I asked the male what he was doing in the area and he claimed he was looking at houses to buy and stated he came into a lot of money and was looking at a house. I asked which house and he gave an address. I asked if that house was for sale and he stated no. I identified the male by driver's license as **Jolee Skenandore**. Dispatch informed me he was on probation for criminal trespass to dwelling which made him looking in multiple home windows more suspicious.

Officer McCrander advised he spoke to the complainant who was stating the suspect entered a home in addition to looking in the complainant's home windows. Jolee consented to a search of his person and I didn't locate anything suspicious. I transported Jolee back to the scene. Ofc McCrander spoke to the resident of ADDRESS 1 Oak Street as well as a couple other parties and we learned that Jolee had entered ADDRESS 1 3 separate times, twice while the resident and her children were asleep, without consent. The residence was 1 house down and across the roadway from ADDRESS 2 Oak Street.

Jolee appeared to still have an open case with bond conditions to have no contact with ADDRESS 2 Oak Street, and conditions of his probation to have no contact with ADDRESS 2 Oak Street and it appeared based upon witness statements that he had at the very least

walked by the house or very near to it. I applied handcuffs to Jolee, checked them for tightness and double locked them and advised him that he was under arrest.

JAIL

While at jail, Jolee agreed to speak to me so I read him his Miranda warning and he agreed to speak to me. I removed handcuffs from Jolee's wrists and turned him over to Brown County Jail. Jolee claimed that he kept going into ADDRESS 1 Oak Street because his brother had called him, and told him to go inside. Jolee stated that he did not have a phone with him however. I asked him why he would go inside three times and he stated because his brother was playing a trick on him.

2. Your complainant's review of the report prepared by Officer Macrander of the De Pere Police Department, which states in part:

On arrival, DBL was outside of his residence at ADDRESS 3 Oak St. He was flagging me down and pointing toward a male walking westbound. I turned westbound on Oak St. The male turned southbound on N 9th St. I activated my emergency lights and the male began walking northbound. Officer Lee Townsend #411 was at the intersection of N 9th St. and Oak St. and stopped the male.

The male was identified as **Jolee M. Skenandore (01/29/1975)**. Jolee was wearing a black Milwaukee Bucks sweatshirt with the hood up, a blue Milwaukee Bucks hat, dark pants and white shoes. Jolee provided that he was staying with a friend on Oak St but could not provide an address. He also said he was looking at a house to buy in the area. He could not provide much information about the house his friend lived at, his friend's name, or the house he wanted to purchase. He said he had gotten the addresses wrong of the house he wanted to buy and the house he was looking at. He voluntarily stated he went into a home in the 700 block of Oak St earlier, thinking it was his friends but realized it was not.

CONTACT WITH COMPLAINANT AND NEIGHBORS

I called DBL to gather more information. He informed me his neighbor (PJR) had more information and that the male had been seen going into ADDRESS 1 Oak St earlier in the morning

I went to ADDRESS 1 Oak St and spoke with the resident, KAV. She provided me the following summary:

She woke up this morning shortly before 0830 hours. At around 0830 hours she went into her living room to turn up the heat on the thermostat when a man opened her front door and walked inside. She asked what he was doing and he said he was at the wrong house. She said he stood there for short time before backing out the door. He was in the home for roughly 10-20 seconds. She described him as possibly a Native American wearing a hat and a dark jacket with a light mustache. She said she had never seen him before. She said her teenagers had a sleepover last night and must have forgotten to lock the front door when they got home.

I went next door to ADDRESS 3 Oak St and spoke with DBL. He said he and his wife were in the living room shortly before he called Dispatch. He said the man came up to the front window

of his living room and looked in. The man then went to the west side of the house and peered in the window. The man saw DBL through the window and took off. DBL said after seeing him the man "booked it" across the street. DBL said the man possibly went into the backyard of ADDRESS 4 Oak before officers made contact with him. He talked to his neighbor PJR who had seen the same man go into a house earlier in the morning.

I spoke with PJR across the street at ADDRESS 5 Oak St. PJR provided me the following summary of information:

This morning, at around 0545 hours a man matching Jolee's previous description knocked on his front door and said he was looking for an "Eric." PJR said no one lives there by that name and the man went on his way. He said for the next hour the same man walked up and down the street. At 0630 hours, PJR went outside to smoke a cigarette and saw the man walk in front of ADDRESS 1 Oak St. The man eventually walked up the steps and inside. The man was inside for about two minutes before coming back out. The man abruptly went back inside the home for another two minutes before exiting, which PJR thought was odd. The man then went to DBL's house and looked through a window. PJR was outside and told the man he knows his neighbors and it wouldn't be who he was looking for (Eric). The man continued walking. PJR also said his son had heard someone knocking on their back door last night at around 2351 hours.

I returned to KAV's and informed her the man had been seen multiple times entering her home. She said she'd follow-up if she found anything was missing from her home.

3. The complainant has also reviewed the records of the Wisconsin Circuit Court Access Program which she has used in the past and found to be reliable which indicate that on January 18, 2022 the defendant was charged with Possession of Methamphetamine and Criminal Trespass to Dwelling in Brown County Case 22CF97 and allowed to be released on bond with a condition that he commit no new crimes. Said bond and its conditions were in effect on said date.

Based on the foregoing, the complainant believes this complaint to be true and correct.
