# **Count 1: FELONY BAIL JUMPING**

Defendant.

The above-named defendant on or about Tuesday, January 9, 2024, in the City of Green Bay, Brown County, Wisconsin, having been charged with a felony in Brown County Case 2023CF1498 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

## Count 2: FELONY BAIL JUMPING

The above-named defendant on or about Tuesday, January 9, 2024, in the City of Green Bay, Brown County, Wisconsin, having been charged with a felony in Brown County Case 2022CF97 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

# Count 3: OPERATING A MOTOR VEHICLE WHILE UNDER THE INFLUENCE - 2ND OFFENSE

The above-named defendant on or about Tuesday, January 9, 2024, in the City of Green Bay, Brown County, Wisconsin, did operate a motor vehicle while under the influence of a controlled substance, contrary to sec. 346.63(1)(a), 346.65(2)(am)2 Wis. Stats., a Misdemeanor, and upon conviction shall, for the second offense counted under s. 343.307(1) within ten (10) years, be fined not less than Three Hundred and Fifty Dollars (\$350) nor more than Eleven

Hundred Dollars (\$1,100), and imprisoned for not less than five (5) days nor more than six (6) months.

And furthermore, invoking the provisions of sec. 343.30(1q)(b)3 and (1q)(c) Wis. Stats., upon conviction, the court shall revoke the defendant's operating privilege for not less than one (1) year nor more than eighteen (18) months, and shall order the defendant to submit to an alcohol and drug abuse assessment and to comply with treatment as a condition of reinstatement.

## **Count 4: DISORDERLY CONDUCT**

The above-named defendant on or about Tuesday, January 9, 2024, in the City of Green Bay, Brown County, Wisconsin, while in a public or private place, did engage in abusive, boisterous, indecent, profane, unreasonably loud, violent or otherwise disorderly conduct, under circumstances in which such conduct tended to cause or provoke a disturbance, contrary to sec. 947.01(1) Wis. Stats., a Class B Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.

Complainant is an Assistant/Deputy District Attorney with the Brown County District Attorney's Office and knows of the above offense(s) on information and belief based upon:

## PROBABLE CAUSE:

The complainant, being duly sworn on oath, swears that she has had the opportunity to review the police reports from Officer Stuedemann of the Green Bay Police Department, and other documents supporting this complaint referenced herein, which are the types of reports and documents kept in the ordinary course of business, which complainant believes to be truthful and reliable because they have proven to be truthful and reliable on numerous occasions in the past.

The complainant further asserts that based upon her review of the referenced reports and/or supporting documents, the incidents alleged occurred in the City of Green Bay, Brown County, Wisconsin.

1. Your complainant's review of the report prepared by Officer Stuedemann of the Green Bay Police Department, which states in part:

On Tuesday, January 9, 2024, at approximately 10:04 p.m., I, Officer M. Stuedemann, 3C2, was on full uniform patrol for the City of Green Bay. While on patrol, I responded to the area of 1100 S. Broadway, Brewski's bar for the report of a possible disturbance. Notes in the call indicated that there were two males physical in the parking lot. Further notes advised that they were the only two males outside and that one male was on the ground. A short time later, the complainant advised that the males were trying to get in a vehicle and that the vehicle was backing out of the lot. The complainant advised he was willing to make a statement of what was going on. Other officers in the area and Officer H. Hermans advised he was behind the vehicle. That vehicle was a bearing Wisconsin plates AKB4228. Other officers advised they were out with the vehicle and I also stopped.

The two other officers were sitting in their patrol vehicles when I approached the driver's side of the vehicle. Officer M. Saharsky advised that the driver had attempted to get out of the vehicle. I walked up to the vehicle and opened the driver's side door. I asked the driver to shut the vehicle off and he advised he had already done so. I could smell a strong odor of an intoxicant coming from the driver's breath and the male attempted to tell me something and I could see his eyes were glassy and bloodshot. He also had extremely slurred speech. Based on the fact that this male was possibly involved in a disturbance, and had attempted to step out of the vehicle and I believed him to be highly intoxicated, I had him step out. I attempted to pat the male down and he started to pull away from me. I told him not to do so. I patted the male down, not finding any weapons. I told other officers they should pull the other male out due to the disturbance that they were possible in and the male I was out with responded with disturbance in a questioning manner.

I then walked him to the front of my patrol vehicle and he said he "didn't do anything". I advised him that he had been driving and that he was highly intoxicated. The male advised that he was trying to get the other guy home safe and that the male was overly intoxicated. I responded and said, "so are you," and his response was, "okay." I then asked the male if he would be willing to do tests to make sure he was okay to be driving and he said "no." The male again tried to pull away, so I advised him that I was going to detain him.

I confirmed again with him that he was not willing to do any more tests and he said he would not and I told him he was under arrest for Operating While Intoxicated; while the other officers could try to further investigate the disturbance. Eventually, I was able to identified the male by his Arizona driver's license as **Jolee M. Skenandore (01/29/75)**. Myself and other officers searched him incident to arrest for his Operating While Intoxicated and I located a water bottle that was labeled Core Hydration. I opened it and smelled it. It had a strong odor of intoxicant and smelled liked vodka. I asked Teletype to check for how many prior Operating While Intoxicated Jolee had. They advised he had two prior convictions and today would be his third. It should be noted that Jolee had a bump on his head that was bleeding. Jolee would advise that he had fallen, but was not involved in any sort of disturbance. He said he was "only trying to get (his) friend home safe". I would later asked Jolee if he would be willing to give me a Preliminary Breath Test (PBT) and said "no." Other officers investigated the disturbance and what led up to the traffic stop.

I would transport Jolee to St. Vincent Hospital for the OWI process. On the way, Jolee became verbally abusive to myself, swearing at me. Once at St. Vincent Hospital, Officer E. Rosenau was able to read the Informing the Accused and Jolee advised that he would not submit to a blood draw. I then applied for a search warrant which would later be granted by the Honorable Judge Liegeois at approximately 11:08 p.m. That signed search warrant is attached to the case.

Officer Rosenau was able to complete the OWI paperwork, as well as issue the revocation paperwork and citations. I entered the room and phlebotomist Yulia Sinina drew blood from Jolee's left arm, which was completed at approximately 11:21 p.m. That blood was later signed, sealed and initialed and placed in the United States Post Office mailbox at the corner of Crooks Street and Jefferson Street. I was able to transport Jolee to the Brown County Jail. Once close to the jail, Jolee again became verbally abusive to me, swearing at me multiple times.

- 2 The written report of Officer E. Rosenau of the Green Bay Police Department indicates that on the above date and time, he had the defendant, after reading the "Informing the Accused", submit to a blood test at St. Vincent's Hospital.
- A radio check with the Wisconsin Department of Motor Vehicles revealed the defendant's operating privilege was revoked resulting from an offense that may be counted under Section 343.307(2), Wis. Stats. Pursuant to 346.65(2)(am), the defendant is subject to the mandatory minimums because he was convicted of Operating While Intoxicated on March 31, 2010 with offense date(s) of December 3, 2009 and suspended as a result thereof.
- 4. The complainant has also reviewed the records of the Wisconsin Circuit Court Access Program which she has used in the past and found to be reliable which indicate that on January 18, 2022 the defendant was charged with Possession of Methamphetamine and Criminal Trespass to Dwelling in Brown County Case 22CF97 and allowed to be released on bond with a condition that he commit no new crimes. Said bond and its conditions were in effect on said date.
- 5. The complainant has also reviewed the records of the Wisconsin Circuit Court Access Program which she has used in the past and found to be reliable which indicate that on August 25, 2023 the defendant was charged with Felony Bail Jumping, Criminal Trespass to Dwelling and Disorderly Conduct in Brown County Case 23CF1498 and allowed to be released on bond with a condition that he commit no new crimes. Said bond and its conditions were in effect on said date.

Based on the foregoing, the complainant believes this complaint to be true and correct.
