

STATE OF WISCONSIN - VS - Jolee Michael Skenandore

Count 4: BATTERY

The above-named defendant on or about Saturday, April 13, 2024, in the City of Green Bay, Brown County, Wisconsin, did cause bodily harm to TAM, by an act done with intent to cause bodily harm to that person, without that person's consent and with the knowledge that the person so harmed did not consent, contrary to sec. 940.19(1) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Count 5: DISORDERLY CONDUCT

The above-named defendant on or about Saturday, April 13, 2024, in the City of Green Bay, Brown County, Wisconsin, while in a public or private place, did engage in abusive, boisterous, indecent, profane, unreasonably loud, violent or otherwise disorderly conduct, under circumstances in which such conduct tended to cause or provoke a disturbance, contrary to sec. 947.01(1) Wis. Stats., a Class B Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.

Count 6: DISORDERLY CONDUCT

The above-named defendant on or about Saturday, April 13, 2024, in the City of Green Bay, Brown County, Wisconsin, while in a public or private place, did engage in abusive, boisterous, indecent, profane, unreasonably loud, violent or otherwise disorderly conduct, under circumstances in which such conduct tended to cause or provoke a disturbance, contrary to sec. 947.01(1) Wis. Stats., a Class B Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.

Count 7: DISORDERLY CONDUCT

The above-named defendant on or about Saturday, April 13, 2024, in the City of Green Bay, Brown County, Wisconsin, while in a public or private place, did engage in abusive, boisterous, indecent, profane, unreasonably loud, violent or otherwise disorderly conduct, under circumstances in which such conduct tended to cause or provoke a disturbance, contrary to sec. 947.01(1) Wis. Stats., a Class B Misdemeanor, and upon conviction may be fined not more than One Thousand Dollars (\$1,000), or imprisoned not more than ninety (90) days, or both.

Complainant is an Assistant District Attorney with the Brown County District Attorney's Office and knows of the above offense(s) on information and belief based upon:

PROBABLE CAUSE:

The complainant, being duly sworn on oath, swears that she has had the opportunity to review the police reports from officers of the Green Bay Police Department and District Attorney Investigator Todd LePine, and other documents supporting this complaint referenced herein, which are the types of reports and documents kept in the ordinary course of business, which

complainant believes to be truthful and reliable because they have proven to be truthful and reliable on numerous occasions in the past.

The complainant further asserts that based upon her review of the referenced reports and/or supporting documents, the incidents alleged occurred in the City of Green Bay, Brown County, Wisconsin.

1. Your complainant's review of the report prepared by Officer Johnson of the Green Bay Police Department, which states in part:

On 4/13/2024, I, Officer D. Johnson manning unit 4B1, was working patrol dressed in a full uniform and operating a fully marked police vehicle for the city of Green Bay Police Department. At or around 6:08 AM, I added myself to assist other officers on a possible four person physical disturbance dispatched out to the Motel 6 at 1614 Shawano Avenue.

On arrival, while other officers were checking the with the front desk, I began driving through the parking lot checking for any signs of disturbance. When driving through, I was flagged down by an older gentleman and I stepped outside to speak to the male. The male immediately advised that he had been "assaulted" and thrown against a wall. The male continued advising that he had been awoken by the tenants in the room above him making loud noises so he smacked on the ceiling of his room to get them to quiet down. The male then said he shortly after stepped outside to smoke a cigarette when an unknown male from the room above him came and punched him in the face and thrown him against the wall.

The male, later identified as TAM, denied any need for EMS and advised he wanted to press charges. TAM identified staying in room *** and pointed to room ***, was where the male that attacked him came from. While I was speaking to TAM, a male was standing outside room *** and I asked TAM if the male standing on the walkway was the male that attacked him. Timothy advised he was not, but the male that did would probably still be in room ***.

When other officers arrived to my position, I went to the second level to speak to those associated to room ***. The aforementioned male standing outside room *** was still standing there and I asked him if he had seen anything. This male, later identified as JSD, advised that there was a disturbance but he was not sure what exactly happened. JSD said he was in his room listening to music when there was a loud banging from below and then the disturbance happened. When I asked if he was involved, JSD advised he was not but that his friend "Jo" was. I asked if Jo was still inside the room, and JSD nodded that he was and I told JSD I needed to speak to Jo to figure out what had happened. JSD went to his door and opened it and called out to Jo and a short time later, a new male stepped to the doorway. I asked what had happened and this male, later identified with a Oneida Tribal ID as **Jolee M. Skenandore (DOB 1/29/1975)**, stated he had been sleeping. When I asked if there had been a disturbance, Jolee was not forthcoming with information by just saying he was sleeping.

I returned down to other officers who had taken over speaking to TAM. This is when I was advised that when Jolee had stepped to the doorway and was visible to TAM, TAM had pointed to Jolee saying Jolee was who had assaulted him. Additionally I was informed there was video evidence of the disturbance and with TAM still wishing to press charges, Jolee was to be taken into custody and jailed.

I returned up to Jolee and requested he step outside to speak to me. Jolee with some hesitation, stepped outside and immediately informed Jolee he was under arrest for disorderly conduct and simple battery and placed him in handcuffs without incident. The handcuffs were checked for proper fit and double locked. I then escorted Jolee to my squad car. While walking, Jolee got upset and was asking why he was being arrested and what happened. I brought him to my squad car and performed a search incident to arrest of Jolee before securing him inside my car. I began reading Jolee his Miranda Rights, during these, Jolee became rather verbal towards me shouting expletives. Jolee was not questioned about the incident due to him advising that he did not understand along with his now uncooperative behavior.

2. Your complainant's review of the reports prepared by Officer Boersma of the Green Bay Police Department, which states in part:

While talking to another male who came out of room ***, by first name of KSV, reaffirmed TAM's story. He stated he had heard the large disturbances going on upstairs, including a loud boom, in which I believed was TAM's rendition of the disturbance as he described as "Wrestle Mania" and saw Jolee come down, walk up to TAM and unprovoked punched TAM in the face, and push him up against the wall.

Again in talking with TAM, he did state that the disturbance that happened, including the battery against himself from Jolee did cause his discomfort as he stated as he went into the wall, he hit his elbow and then his ribs which caused him discomfort. He also stated to me and other officers that he did not give Jolee any permission to hit him whatsoever.

While Officer Johnson went upstairs to make contact with room ***, Jolee poked his head out of the room and without officers looking up or asking if that was the male, TAM looked up, pointed at Jolee and stated something along the lines of, "That's him, that's who hit me."

At that point, myself, Officer Dudley and Officer Johnson got together and made a collective decision that based off of the statements earlier from JB-E, TAM's recollection of the incident, including him wanting to press charges, not giving Jolee permission to hit him, and that the actions that Jolee did against him, caused him discomfort that Jolee should be placed under arrest, instead of municipal citations, as the close proximity of all the hotel rooms in the complex on top of the fact that Motel 6 themselves were calling in, in regards to Jolee's actions throughout the night.

At that time, Jolee was advised that he was being placed under arrest and was transported to the Brown County Jail by Officer Johnson.

Officer Elsinger went to the front desk and left the Axon Link for the front desk personnel to try to get the video footage of what happened out back of room ***; however, on the first floor, I went back and talked to KSV again who confirmed his story in regards to Jolee coming down unprovoked after a large noise disturbance and without any provocation, punched TAM and pushed him up against the wall.

3. Your complainant's review of the report prepared by Officer Dudley of the Green Bay Police Department, which states in part:

Upon arrival, I walked to the front entrance to speak with Motel 6 staff. A Hispanic male, later verbally identified as JB-E. JB-E identified he had staff contact the police. JE-B was highly animated and spoke in a sharp, fast tone. JE-B rapidly spoke about a male that was intoxicated who had caused a loud disturbance. When JE-B exited his room a male had called him a "Nigger." JE-B further advised he yelled back at the male that he was not black and, in fact, he was Puerto Rican. JE-B described the male as loud, boisterous and was waking everyone up inside the motel. JE-B just wanted the male to be quiet and go in his room. JE-B further advised that two would push each other back and forth, resulting in a scuffle; however, didn't elaborate further.

I asked JE-B if he wanted any charges pressed to which he stated no. JE-B only wanted the male to calm down and go to bed. It should be noted while looking at JE-B, I could see several signs of a scuffle on his skin. There were small abrasions, possibly from when he was pushing back and forth with the unidentified male.

4. Your complainant's review of the report prepared by DA Investigator LePine, who states in part:

On Monday, April 15th 2024 at approximately 11 am I attempted telephone contact with victim, T M. I telephoned ***-***-**** which indicated the phone was "not accepting calls/mailbox full". I searched the police report and called the original complainant listed in CAD notes as "Front Desk Staff" ***-***-****. An unidentified male answered the phone. I introduced myself to him and told him I was attempting to contact TAM in Room #***. The male said, "I didn't really witness anything but I'll get him for you".

After several minutes, a different male came onto the phone. I confirmed he was indeed TAM. I asked him to describe for me what had occurred. He said the male had grabbed him and swung him around by his coat. TAM said he was hit a couple times, too. He said he fell to the ground "a couple times". TAM said his ribs hurt the most. He indicated his ribs are still very sore. He also indicated he strained his right knee from getting swung around. TAM said he never swung on the offender.

5. The complainant has also reviewed the records of the Wisconsin Circuit Court Access Program which she has used in the past and found to be reliable which indicate that on January 18, 2022 the defendant was charged with Possession of Methamphetamine and Criminal Trespass to Dwelling in Brown County Case 22CF97 and allowed to be released on bond with a condition that he commit no new crimes. Said bond and its conditions were in effect on said date.

6. The complainant has also reviewed the records of the Wisconsin Circuit Court Access Program which she has used in the past and found to be reliable which indicate that on August 25, 2023 the defendant was charged with Felony Bail Jumping, Criminal Trespass to Dwelling and Disorderly Conduct in Brown County Case 23CF1498 and allowed to be released on bond with a condition that he commit no new crimes. Said bond and its conditions were in effect on said date.

7. The complainant has also reviewed the records of the Wisconsin Circuit Court Access Program which she has used in the past and found to be reliable which indicate that on January 10, 2024 the defendant was charged with Felony Bail Jumping (2 Counts), OWI 2nd and Disorderly Conduct in Brown County Case 24CF71 and allowed to be released on bond with a condition that he commit no new crimes. Said bond and its conditions were in effect on said date.

Based on the foregoing, the complainant believes this complaint to be true and correct.
