**Count 4: FELONY BAIL JUMPING**

The above-named defendant on or about Sunday, September 1, 2024, in the City of Green Bay, Brown County, Wisconsin, having been charged with a felony in Brown County Case 2019CF969 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

**Count 5: FELONY BAIL JUMPING**

The above-named defendant on or about Tuesday, October 1, 2024, in the City of Green Bay, Brown County, Wisconsin, having been charged with a felony in Brown County Case 2019CF969 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

**Count 6: FELONY BAIL JUMPING**

The above-named defendant on or about Friday, November 1, 2024, in the City of Green Bay, Brown County, Wisconsin, having been charged with a felony in Brown County Case 2019CF969 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

**Count 7: FELONY BAIL JUMPING**

The above-named defendant on or about Sunday, December 1, 2024, in the City of Green Bay, Brown County, Wisconsin, having been charged with a felony in Brown County Case 2019CF969 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

**Count 8: FELONY BAIL JUMPING**

The above-named defendant on or about Wednesday, January 1, 2025, in the City of Green Bay, Brown County, Wisconsin, having been charged with a felony in Brown County Case 2019CF969 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

**Count 9: FELONY BAIL JUMPING**

The above-named defendant on or about Saturday, February 1, 2025, in the City of Green Bay, Brown County, Wisconsin, having been charged with a felony in Brown County Case

**Count 10: FELONY BAIL JUMPING**

The above-named defendant on or about Saturday, March 1, 2025, in the City of Green Bay, Brown County, Wisconsin, having been charged with a felony in Brown County Case 2019CF969 and having been released from custody under Chapter 969 Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

**Count 11: FELONY BAIL JUMPING**

Stats., did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

**Count 12: FELONY BAIL JUMPING**

The above-named defendant on or about Wednesday, April 30, 2025, in the City of Green Bay, Brown County, Wisconsin, having been charged with a felony in Brown County Case 2019CF969 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

**Count 13: FELONY BAIL JUMPING**

The above-named defendant on or about Sunday, December 10, 2024, in the City of Green Bay, Brown County, Wisconsin, having been charged with a felony in Brown County Case 2024CF521 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

**Count 14: FELONY BAIL JUMPING**

The above-named defendant on or about Wednesday, January 1, 2025, in the City of Green Bay, Brown County, Wisconsin, having been charged with a felony in Brown County Case 2024CF521 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

### **Count 15: FELONY BAIL JUMPING**

The above-named defendant on or about Saturday, February 1, 2025, in the City of Green Bay, Brown County, Wisconsin, having been charged with a felony in Brown County Case 2024CF521 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

### **Count 16: FELONY BAIL JUMPING**

The above-named defendant on or about Saturday, March 1, 2025, in the City of Green Bay, Brown County, Wisconsin, having been charged with a felony in Brown County Case 2024CF521 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

### **Count 17: FELONY BAIL JUMPING**

The above-named defendant on or about Tuesday, April 1, 2025, in the City of Green Bay, Brown County, Wisconsin, having been charged with a felony in Brown County Case 2024CF521 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

### **Count 18: FELONY BAIL JUMPING**

The above-named defendant on or about Wednesday, April 30, 2025, in the City of Green Bay, Brown County, Wisconsin, having been charged with a felony in Brown County Case 2024CF521 and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of his bond, contrary to sec. 946.49(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

Complainant is an Assistant District Attorney with the Brown County District Attorney's Office and knows of the above offense on information and belief based upon:

### **PROBABLE CAUSE**

1. Your complainant's review of the Brown County District Attorney's Office case notes and the records of the Wisconsin Circuit Court Access Program (CCAP) website, which records are believed to be truthful and reliable as they are records kept in the ordinary course of departmental business. Said records reflect that in Brown County Case 2019CF969, on June 18, 2019, Franklin Ortiz, dob: 08/22/2001, the defendant, made an initial appearance in Brown County Court on felony charges of Conspiracy to Commit Delivery of Heroin >50g and Conspiracy to Commit Delivery of THC >10,000g. At that time, Court Commissioner Chad

Resar imposed a \$25,000 cash bond, which included a condition that the defendant must report to CJS within 24 hours of release and comply with CJS. The case was scheduled for an initial appearance.

On May 04, 2020, the cash bond was amended down to \$5,000 cash by Honorable Judge Timothy A. Hinkfuss. The \$5000 cash bond was posted on the defendant's behalf on the same date.

2. Your complainant's review of the Brown County District Attorney's Office case notes and the records of the Wisconsin Circuit Court Access Program (CCAP) website, which records are believed to be truthful and reliable as they are records kept in the ordinary course of departmental business. Said records reflect that in Brown County Case 2024CF521, on December 9, 2024, Franklin Ortiz, dob: 08/22/2001, the defendant, made an initial appearance in Brown County Court on felony charges of ten counts of Felony Bail Jump. At that time, Honorable Judge Timothy A. Hinkfuss imposed a \$1,000 signature bond, which included a condition that the defendant must report to CJS within 24 hours of release and comply with CJS. The case was scheduled for an initial appearance.

3. On July 30, 2024 your complainant received a report from CJS which indicates that: "On 06/18/19, Franklin Ortiz was ordered to report and comply with Criminal Justice Service (CJS). Franklin Ortiz has failed to report to CJS since 05/23/24. Multiple attempts since 05/23/24 to make contact with Franklin Ortiz has been unsuccessful. Franklin Ortiz has failed to report to CJS for his automated check ins on 06/22/24, 06/28/24, and 07/28/24. As of 07/30/24, Franklin Ortiz does not appear to be in custody. CJS supervision of Franklin Ortiz has been suspended and will resume when Franklin Ortiz re-establishes compliance with our program. Franklin Ortiz has a court appearance on 12/9/2024 at 9:30am in Branch 7."

4. On December 3, 2024 your complainant received a report from CJS which indicates: "On 06/18/19, Franklin Ortiz was ordered to report and comply with Criminal Justice services (CJS). Franklin Ortiz failed to report to report to CJS since 05/23/24. Multiple attempts since 05/23/24 to make contact with Franklin Ortiz has been unsuccessful. Franklin Ortiz has failed to report to CJS for his automated check ins on 06/22/24, 06/28/24, 07/28/24, 08/28/24, 09/28/24, 10/28/24, and 11/29/24. As of 12/3/24, Franklin Ortiz does not appear to be in custody. CJS supervision of Franklin Ortiz has been suspended and will resume when Franklin Ortiz re-establishes compliance with our program. Franklin Ortiz has a court appearance on 12/9/2024 at 9:30am in Branch 7."

5. On December 10, 2024 your complainant received a report from CJS which indicates: "On 12/09/24, Franklin Ortiz was ordered to report and comply with Criminal Justice Services (CJS). Franklin Ortiz failed to report to CJS on 12/09/24 as ordered by court. As of 12/10/24, Franklin Ortiz does not appear to be in custody. CJS supervision of Franklin Ortiz has been suspended and will resume when Franklin Ortiz re-establishes compliance with our program. Franklin Ortiz has a court appearance on 2/7/2025 at 4:00pmm in Branch 7."

6. On March 11, 2025, your complainant received a report from CJS which indicates: "On 12/09/24, Franklin Ortiz was ordered to report and comply with Criminal Justice Services (CJS). Franklin Ortiz has failed to report to CJS consistently on a monthly basis as ordered by court. As of 03/11/25, Franklin Ortiz does not appear to be in custody. CJS supervision of Franklin Ortiz has been suspended and will resume when Franklin Ortiz re-establishes

compliance with our program. Franklin Ortiz has a court appearance on 5/2/2025 at 9:30am in Branch 7.”

7. On April 30, 2025, your complainant received a report from CJS which indicates: “On 12/09/24, Franklin Ortiz was ordered to report and comply with Criminal Justice Services (CJS). Franklin Ortiz has failed to report to CJS consistently on a monthly basis as ordered by court. As of 04/30/25, Franklin Ortiz has not attempted to make contact with CJS since 06/24/24. As of 04/30/25, Franklin Ortiz does not appear to be in custody. CJS supervision of Franklin Ortiz has been suspended and will resume when Franklin Ortiz re-establishes compliance with our program. Franklin Ortiz has a court appearance on 5/2/2025 at 9:30am in Branch 7.”

Based on the foregoing, the complainant believes this complaint to be true and correct.
